Information summary

Subject: Israeli violations, acts of aggression and other activities from 1 to 7 October 2007

Air violations

On **1 October 2007**, between 1945 hours and 2150 hours, two Israeli enemy warplanes violated Lebanese airspace over Yarun and circled between Shikka and the south. They then departed Lebanese airspace over Al-Naqurah.

Between 2230 hours and 2355 hours, an Israeli enemy reconnaissance aircraft violated Lebanese airspace over the sea off Tyre and circled over Beirut and Tyre. It then departed Lebanese airspace over Al-Naqurah.

On **2 October 2007**, between 1230 hours and 1255 hours, two Israeli enemy warplanes violated Lebanese airspace over Yarun and flew in a northerly direction as far as Shikka. They then departed Lebanese airspace over Al-Naqurah.

Between 1305 hours and 1318 hours, two Israeli enemy warplanes violated Lebanese airspace over Al-Naqurah and flew in a northerly direction as far as Beirut. They then returned south and departed Lebanese airspace over Rumaysh.

Between 1339 hours and 1350 hours, two Israeli enemy warplanes violated Lebanese airspace over Beirut, flying in a northerly direction. They departed Lebanese airspace over Alma al-Sha`b.

Between 1355 hours and 1410 hours, two Israeli enemy warplanes violated Lebanese airspace over Aytarun and flew in a northerly direction as far as Beirut. They then headed south and departed Lebanese airspace over Rumaysh.

Between 1724 hours and 1900 hours, an Israeli enemy reconnaissance aircraft violated Lebanese airspace over the sea off Tyre and circled over the sea between Sidon and Tyre. It then departed Lebanese airspace over the sea off Al-Naqurah.

On **3 October 2007**, between 1135 hours and 1310 hours, two Israeli enemy warplanes violated Lebanese airspace over Dayr Mimas, flew in a northerly direction as far as Shikka, and circled over it and over regions of the south, the Bekaa and Beirut. They then departed Lebanese airspace over Alma al-Sha`b.

On **4 October 2007**, at 2344 hours, an Israeli enemy reconnaissance aircraft violated Lebanese airspace over the sea off Al-Naqurah, flew as far as Beirut and circled over it. It then departed Lebanese airspace on 5 October 2007 at 0100 hours over the sea off Al-Naqurah.

On **5 October 2007**, between 1035 hours and 1145 hours, two Israeli enemy warplanes violated Lebanese airspace over Kafr Kila and circled over regions of the south and the north. They then departed Lebanese airspace over Alma al-Sha`b.

On **6 October 2007**, between 2225 hours and 2345 hours, two Israeli enemy warplanes violated Lebanese airspace over Al-Naqurah, flew in a northerly direction

as far as Beirut, and circled over Beirut and the south. They then departed Lebanese airspace over Alma al-Sha`b.

At 2256 hours, an Israeli enemy reconnaissance aircraft violated Lebanese airspace over the sea off Al-Bayada, flying in a north-easterly direction, and circled between Beirut and the south. It then departed Lebanese airspace on 7 October 2007 at 0030 hours over the sea off Al-Naqurah.

On **7 October 2007**, between 0950 hours and 1210 hours, an Israeli enemy reconnaissance aircraft violated Lebanese airspace over Kafr Kila and circled over the south. It then departed Lebanese airspace over Alma al-Sha`b.

Between 1105 hours and 1225 hours, two Israeli enemy warplanes violated Lebanese airspace over Kafr Kila and circled over Shikka, Al-Arz, Beirut and the south. They then departed Lebanese airspace over Rumaysh.

Sea violations

On **4 October 2007**, at 2345 hours, the Israeli enemy fired flares in the wake of a Lebanese fishing boat located 900 metres from the line of buoys inside Lebanese territorial waters and 300 metres from the coast.

Acts of aggression in the field

On **6 October 2007**, at 2114 hours, the Israeli enemy shone a searchlight from its Zarit barracks position towards the Mirwahin-Jabal Balat-Ramiyah triangle.
