Land violations in May 2016

| <i>Date</i> | <i>Time</i> | <i>Nature of violation</i> |
|-------------|--------------|---|
| 2 May | 1130 | From inside occupied Palestinian territory, opposite Labbunah at point B3, as a Lebanese Army patrol was erecting observation towers on the Lebanese-Palestinian border, an Israeli enemy patrol trained a machine gun mounted on a Hummer vehicle on members of the patrol. |
| 10 May | – | Opposite Ra's al-Naqurah, between points AP15 and B2, an Israeli enemy soldier positioned himself behind one of the concrete blocks and aimed his machine gun, mounted on a bipod and fitted with a scope, at a Lebanese Army patrol. |
| | 0800 | Opposite the Ra's al-Naqurah area, members of an enemy patrol (eight soldiers) cut a hole in the technical fence and crossed over without violating the Blue Line. At 1230 hours they returned into occupied territory. At 1430 hours, members of the patrol returned and closed the hole in the fence, while one of them kept his weapon trained on a Lebanese Army patrol. |
| 12 May | 1320 | Opposite the Ibl al-Qamh area, enemy soldiers trained the cannon of a tank on Lebanese territory. |
| 18 May | 1000 | Opposite the town of Alma al-Sha'b in the vicinity of the Hanita East 2 post, one member of an Israeli enemy patrol made obscene gestures at a Lebanese Army patrol. |
| 23 May | 1200 | From inside occupied Palestinian territory, opposite the Wazzani resort, a Defender vehicle fitted with a pole-mounted camera pointed its camera at Lebanese territory. The vehicle drove off at 1540 towards occupied territory. |
| 25 May | 1515 | From their position inside occupied Palestinian territory, opposite the town of Alma al-Sha'b, the Israeli enemy trained a machine gun, mounted on a Humvee vehicle, on members of a Lebanese Army patrol. |
| | 1550 1700 | Inside the occupied Shab'a Farms, several explosions and bursts of medium automatic-weapon fire were heard. |
| 30 May | 0800 | Opposite the Kafr Killa-Udaysah road, a Hummer vehicle, a grader, a wheeled bulldozer and an excavator belonging to the Israeli enemy spread gravel on the road along the technical fence. One of the soldiers trained his weapon on Lebanese territory. The Israeli enemy finished work and the vehicles withdrew in the direction of occupied territory at 1630 hours. |
| 31 May | 1015 | From inside occupied Palestinian territory, opposite the town of Kafr Killa, an Israeli enemy patrol consisting of an off-road vehicle and a construction vehicle drove up and members of the patrol started working on the technical fence. Some soldiers loaded their weapons and trained them on a Lebanese Army patrol and hurled obscenities at the Lebanese soldiers. The enemy patrol left in the direction of occupied territory at 1030 hours. |

The launch then left in the direction of occupied Palestinian territorial waters. |
| | 1911 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of three minutes, and proceeded on its way for some 222 metres. The launch then left in the direction of occupied Palestinian territorial waters. |
| 3 May | 0335 0430 | From inside occupied Palestinian waters, off Ra's al-Naqurah, an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for two periods of five minutes and one minute, respectively. |
| | 0336 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of six minutes, and proceeded on its way for some 240 metres. The launch then left in the direction of occupied Palestinian territorial waters. |
| | 0421 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of seven minutes, and proceeded on its way for some 370 metres. The launch then left in the direction of occupied Palestinian territorial waters. |
| | 2225 2230 | From its position in occupied Palestinian territory opposite Ra's al-Naqurah, the Israeli enemy twice directed a searchlight towards Lebanese territorial waters, first for 40 seconds and then for 30 seconds. |
| 5 May | 0822 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of seven minutes, and proceeded on its way for some 205 metres. The launch then left in the direction of occupied Palestinian territorial waters. |
| | 1810 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of three minutes, and proceeded on its way for some 180 metres. The launch then left in the direction of occupied Palestinian territorial waters. |
| 6 May | 0435 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of 10 minutes, and proceeded on its way for some 277 metres. The launch then left in the direction of occupied Palestinian territorial waters. |
| | 0515 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of 12 minutes, and proceeded on its way for some 407 metres. The launch then left in the direction of occupied Palestinian territorial waters. |

The launch then left in the direction of occupied Palestinian territorial waters. |
| | 2230 | From inside occupied Palestinian territorial waters, opposite Ra's al-Naqurah, an Israeli enemy military launch trained a searchlight on the Ra's al-Naqurah position for a period of 10 seconds. |
| 8 May | 1250 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of two minutes, and proceeded on its way for some 130 metres. The launch then left in the direction of occupied Palestinian territorial waters. |
| 13 May | 0750 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree 6433 (2011), for a period of five minutes, and proceeded on its way for some 310 metres, whereupon it detonated noise bombs within Lebanese territorial waters and fired a number of rounds in a southerly direction. The launch then left in the direction of occupied Palestinian territorial waters. |
| 14 May | 0020 0320 | From its position in occupied Palestinian territory opposite Ra's al-Naqurah, the Israeli enemy trained a searchlight on Lebanese territorial waters five times, the first time for 40 seconds, the next four times for 30 seconds each. |
| 17 May | 0400 | From inside occupied Palestinian territorial waters, off Ra's al-Naqurah, an Israeli enemy military launch trained a searchlight on a Lebanese fishing vessel located in Lebanese territorial waters, then the launch sounded a siren. |
| | 1800 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of seven minutes, and proceeded on its way for some 203 metres. The launch then left in the direction of occupied Palestinian territorial waters. |
| 18 May | 1800 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of three minutes, and proceeded on its way for some 259 metres. | 31 May | 1540 | Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a period of three minutes, and proceeded on its way for some 166 metres. The launch then left in the direction of occupied Palestinian territorial waters. |
