**Land violations committed in November 2016**

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
3 November	1030	The Israeli enemy continued work it had begun on 15 August 2016 inside the occupied Shab'a Farms opposite observation point OP2 of the United Nations Interim Force in Lebanon (UNIFIL) Indian contingent between the old Shahal post and the Radar post, using a D9 bulldozer and two trench-diggers escorted by a hostile patrol. The Israeli enemy finished its work at 1530 hours, and the vehicles left in the direction of occupied territory.
6 November	1015	Opposite the town of Blida at point BP28, an Israeli enemy patrol comprising two Hummer vehicles approached. Four soldiers disembarked and dismantled a metal box containing equipment for maintaining the technical fence. The hostile soldiers directed curses at a Lebanese Army patrol that was observing the activity from the Lebanese side. At 1030 hours, the two vehicles left in the direction of occupied territory.
8 November	0900	The Israeli enemy continued work it had begun on 15 August 2016 inside the occupied Shab'a Farms at Jabal al-Shahal, using a D9 bulldozer and three trench-diggers escorted by a patrol comprising 20 soldiers and a Merkava tank. The Israeli enemy finished its work at 1630 hours.
	1000 1030	Opposite the town of Alma al-Sha'b, while Israeli enemy forces were clearing brush north of the technical fence in the area around point BP5 with a trench-digger, the mechanical arm of the trench-digger crossed over the Blue Line into Lebanese territory. An enemy Hummer vehicle escorting the trench-digger pointed its machine gun at Lebanese Army patrol members.
9 November	1330	On the outskirts of the town of Kafr Shuba, Israeli enemy forces violated the line of withdrawal and abducted the shepherd Ahmad al-Samman (a Syrian). At 1630 hours, they released him near observation point OP4 belonging to the Indian UNIFIL contingent.
	1430	From inside occupied Palestinian territory in the area surrounding point B3 east of Ra's al-Naqurah, members of an Israeli enemy patrol pointed their weapons at a Lebanese Army patrol.
	1600	From inside occupied Palestinian territory south of Dahirah, an Israeli enemy armoured personnel carrier pointed its weapon at a Lebanese Army patrol.
10 November	1050	Between Tallat al-Ibad and Manarah, near point B71-2, while five civilians were in the vicinity of the Blue Line inside Lebanese territory, an Israeli enemy patrol threw a smoke bomb inside occupied territory. Members of the hostile patrol pointed their firearms in the direction of said civilians.

14 November	0940	From inside occupied territory opposite the town of Mays al-Jabal near points B70, B71 and BP32, Israeli enemy soldiers pointed their weapons at Lebanese territory.
	1810	On the outskirts of the town of Kafr Shuba, Israeli enemy soldiers shone a flashlight from their position at Jabal al-Rus (Ruwaysat al-Alam) towards the Lebanese Army L360 position.
16 November	0930	Opposite the town of Aytarun, while the Israeli enemy was clearing brush using a trench-digger, the mechanical arm of the trench-digger crossed approximately one and a half metres over the Blue Line into Lebanese territory between points M6-2 and BP27.
17 November	0900	Opposite the town of Aytarun, while the Israeli enemy was clearing brush using a trench-digger, the mechanical arm of the trench-digger crossed the Blue Line into Lebanese territory several times between points M6-2 and BP26.
20 November	0900	From inside occupied Palestinian territory opposite the town of Rumaysh, members of an Israeli enemy patrol pointed their firearms at a Lebanese Army patrol.
	1130	Several explosions were heard from inside the occupied Shab‘a Farms.
	1300	
	–	A fire broke out on the outskirts of the towns of Zahirah and Yarin, causing some 14 landmines previously laid by the Israeli enemy to explode. There were no injuries.
	–	A fire broke out on the outskirts of the town of Bustan at Birkat Risha, causing some 145 landmines previously laid by the Israeli enemy to explode. There were no injuries. At 2120 hours, an Israeli enemy fire engine sprayed water at Lebanese territory from inside occupied territory opposite Birkat Risha to prevent the fire from spreading into occupied Palestinian territory.
	1250	Opposite Ra’s al-Naqurah, in the area surrounding point M2, while an Israeli enemy trench-digger was clearing brush from the surrounding area, the mechanical arm of the trench-digger crossed the technical fence by about two metres in the area to which Lebanon maintains a claim.
	1545	
21 November	1115	On the outskirts of the town of Alma al-Sha‘b at Ayn Alma, a fire broke out, causing some nine landmines previously laid by the Israeli enemy to explode. There were no injuries.
	–	From inside occupied territory, the Israeli enemy directed a searchlight from its position at Ra’s al-Naqurah towards the Lebanese Army observation tower for a period of 10 seconds.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	1230	On the outskirts of Kafr Shuba at Birkat Ba'tha'il, an Israeli enemy patrol comprising a Merkava tank and two armoured personnel carriers approached. Some 10 soldiers disembarked and crossed the line of withdrawal (the Blue Line in the area to which Lebanon maintains a claim). They attempted unsuccessfully to abduct the shepherd Ramzi Abdul'al. However, the aforementioned patrol led a herd of goats back into occupied territory. At 1900 hours, the Israeli enemy returned the aforementioned herd of goats.
22 November	1035	Two Israeli enemy bulldozers were observed moving from the Fashkul post towards the Abbasiyah post inside the occupied Shab'a Farms. The aforementioned forces fired several bursts of medium machine-gun fire at the perimeter of the Fashkul post.
23 November	0750	Inside the occupied Shab'a Farms, at the Israeli enemy Radar post, an explosion was heard and rising smoke was observed.
	0920 1045	From inside occupied Palestinian territory opposite the town of Blida near point M6, Israeli enemy patrol members pointed their weapons at an Observer Group Lebanon patrol stationed inside Lebanese territory.
26 November	1330	From inside occupied Palestinian territory, while two Humvee vehicles were travelling towards Tall Murad, the occupants pointed a 12.7 mm machine gun at a Lebanese Army patrol near the Lebanese Army Lahlah position. The two vehicles left in the direction of occupied territory at 1350 hours.
28 November	0900	Opposite the town of Alma al-Sha'b, two Israeli enemy excavators moved blocks, removed fortifications and moved prefabricated sheds located at the enemy position east of Hanita 2, near point BP6 approximately 100 metres to the west of the aforementioned position. The excavators were escorted by two Hummer vehicles. At 0935 hours, one of the enemy personnel pointed a machine gun mounted on the Hummer vehicle at members of a Lebanese army patrol. The work ended at 1635 hours, and the patrol left in the direction of occupied territory.
29 November	1615	On the outskirts of Alma al-Sha'b, while Lebanese Army personnel were conducting a routine patrol along the border opposite point BP6, an Israeli enemy patrol pointed its machine guns at the Lebanese Army patrol personnel.

**Sea violations committed in November 2016**

2 November	1649	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) of 1 October 2011, for a four-minute period, and proceeded on its way for some 170 metres. The launch then left in the direction of occupied Palestinian territorial waters.
3 November	0505	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a five-minute period, and proceeded on its way for some 590 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0509	From inside occupied Palestinian territorial waters off Ra's al-Naqurah, an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a one-minute period.
	0532	From inside occupied Palestinian territorial waters off Ra's al-Naqurah, an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a three-minute period.
	0538	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a four-minute period, and proceeded on its way for some 500 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 0544 hours, it violated the boundary again, for a three-minute period, and proceeded on its way for some 405 metres. It also sounded warning sirens. The launch then left in the direction of occupied Palestinian territorial waters.
	0838	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a two-minute period, and proceeded on its way for some 260 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	1306	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a four-minute period, and proceeded on its way for some 240 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 1350 hours, it violated the boundary again, for a five-minute period, proceeding some 240 metres, and released divers. The launch then left in the direction of occupied Palestinian territorial waters.
4 November	1531	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a three-minute period, and proceeded on its way for some 240 metres. The launch then left in the direction of occupied Palestinian territorial waters.

6 November	1405	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree 6433 (2011), for a five-minute period, and proceeded on its way for some 200 metres into Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters. At 1538 hours, it violated the boundary again, for a two-minute period, and proceeded on its way for some 180 metres. The launch then left in the direction of occupied Palestinian territorial waters.
7 November	1618	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a two-minute period, and proceeded on its way for some 90 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	1743	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011), for a two-minute period, and proceeded on its way for some 150 metres. The launch then left in the direction of occupied Palestinian territorial waters.
10 November	1047	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 15-minute period, and proceeded on its way for some 330 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 1107 hours, it again violated the boundary, for a 22-minute period, and proceeded on its way for some 445 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 1209 hours, it again violated the boundary, for a 20-minute period, and proceeded on its way for some 315 metres. The launch then left in the direction of occupied Palestinian territorial waters.
11 November	0331	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a one-hour-and-22-minute period, and proceeded on its way for some 70 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0900	Off Ra's al-Naqurah, eight plastic balloon-shaped objects — two of them blue, two of them black, one of them pink and three of them white — belonging to the Israeli enemy crossed the southern maritime boundary established by decree No. 6433 (2011).
	1750	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 20-minute period, and proceeded on its way for some 380 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	2148	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a three-minute period, and proceeded on its way for some 245 metres. The launch then left in the direction of occupied Palestinian territorial waters.

21 November	1606	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a two-minute period, and proceeded on its way for some 300 metres. The launch then left in the direction of occupied Palestinian territorial waters.
22 November	1628	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a three-minute period, and proceeded on its way for some 290 metres. The launch then left in the direction of occupied Palestinian territorial waters.
23 November	1418	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a two-minute period, and proceeded on its way for some 240 metres. 27 November	0340	From inside occupied Palestinian territory, the Israeli enemy directed a searchlight towards Lebanese territory from its position opposite Ra's al-Naqurah.

	0516	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a five-minute period, and proceeded on its way for some 185 metres. The launch then left in the direction of occupied Palestinian territorial waters. It also released a charge into occupied Palestinian territorial waters and sounded warning sirens.
	0635	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a five-minute period, and proceeded on its way for some 426 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	2240	From inside occupied Palestinian territory at its position off Ra's al-Naqurah, the Israeli enemy directed a searchlight towards Lebanese territorial waters.
