Annex to the identical letters dated 29 June 2018 from the Permanent Representative of Lebanon to the United Nations addressed to the Secretary-General and the President of the Security Council

Land violations committed in May 2018

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
2 May	1130	The herder Isma‘il Sa‘b took his livestock to graze on the outskirts of the town of Shab‘a, near observation point OP1, which is staffed by the Indian contingent of the United Nations Interim Force in Lebanon (UNIFIL). The livestock returned at 16.30 hours without the shepherd. At 2020 hours, the liaison unit of the UNIFIL reported that the shepherd had been detained by the Israeli enemy.
	1715	From inside occupied Palestinian territory, opposite the town of Khiyam near Barad al-Tuffah, the Israeli enemy hurled four smoke bombs towards several civilians in Sahl al-Khiyam. The bombs landed inside Lebanese territory, but no one was injured.
3 May	1000	A Lebanese Army patrol came across a suspicious object, which appeared to be a bomb, inside Lebanese territory near point BP87. It is believed that the object was one of the four smoke bombs that the Israeli enemy hurled towards civilians in Sahl al-Khiyam on 2 May 2018.
	1000 1035	The sound of several bursts of medium and light weapon fire was heard around the Summaqah outpost in the occupied Shab‘a Farms.
	1130	On the outskirts of Shab‘a town, near observation point OP2, which is staffed by the Indian contingent of UNIFIL, the Israeli enemy released shepherd Isma‘il Sa‘b, whom they had abducted on 2 May 2018. The enemy did not coordinate his release with UNIFIL.
	1145	Inside occupied Palestinian territory, opposite point BP14 and the town of Rumaysh, an Israeli enemy patrol comprising a Merkava tank, 10 personnel and a police dog crossed the technical fence, proceeding on their way approximately 20 metres without crossing the Blue Line. They inspected the site and photographed the Lebanese Army position at the wall. Meanwhile, the tank pointed its cannon towards the position. The hostile patrol left at 1235 hours and returned to occupied Palestinian territory.
	1700	Inside Lebanese territory, in the area of Zawtar al-Sharqiyah, Husayn Yunis found balloons in the garden of his house that had Hebrew writing on them. A Lebanese Army patrol was dispatched to the site. The patrol took the balloons and began an investigation.
8 May	1600 1900	Inside the occupied Shab‘a Farms, on the outskirts of Sha‘ba town, several bursts of light and medium military-weapon fire were heard.
9 May	0940	Inside occupied Palestinian territory, opposite the Army checkpoint at Udaysah, the Israeli enemy installed a camera on an emplacement opposite the checkpoint and pointed it towards Lebanese territory. At 1300 hours, the Israeli enemy removed camera.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
10 May	1530	On the outskirts of Kafr Shuba town, in the locality of Birkat Ba‘tha’il, some 48 cows crossed the so-called line of withdrawal. They headed back towards the occupied territories at 1940 hours.
11 May	1148	An Israeli enemy patrol comprising two Hummer vehicles and a construction vehicle stopped opposite the town of Udaysah, at point TP37. Four soldiers descended from the vehicles and carried out maintenance work on the technical fence. One of the soldiers pointed a 12.7 mm calibre machine gun towards Lebanese territory. The work ended at 13.10 hours and the hostile patrol left in the direction of occupied territory.
	1715 1750	Inside the occupied Shab‘a Farms, the sound of light and medium military-weapon fire was heard.
12 May	915	On the outskirts of Kafr Shuba town, in the locality of Birkat Ba‘tha’il, some 25 cows crossed the so-called line of withdrawal. They headed back towards the occupied territories at 1730 hours.
14 May	1510 1600	Inside the occupied Shab‘a Farms, several bursts of light and medium military-weapon fire were heard.
	2215	An Israeli enemy foot patrol approached from inside occupied Palestinian territory, opposite the Wazzani resort. The patrol members directed a searchlight towards Lebanese territory before leaving at 2310 hours.
15 May	1210	Opposite Yarun, an Israeli enemy patrol comprising one Hummer vehicles and two civilian vehicles arrived at the Jabal al-Tayyarat west position and carried out maintenance work there. As they were working, a member of the enemy patrol pointed his weapon towards the members of a Lebanese Army patrol that was on the Lebanese side of that location. The enemy patrol departed and headed into occupied territory at 1320 hours.
16 May	1000	Inside occupied territory, opposite the Rumaysh gate position, a Merkava tank crossed the technical fence near the Khallat al-Budiyah position. The tank took up a position at that location and pointed its cannon towards Lebanese territory, without violating the Blue Line. The tank departed and headed towards the Rumaysh gate at 1100 hours.
	1600	As the shepherd Mahir Hamdan was tending to a herd of livestock on the outskirts of Shab‘a town, locality of Shahl, an Israeli enemy foot patrol consisting of eight personnel crossed some 30 metres past the line of withdrawal (the Blue Line, to which a claim is maintained in that area) and attempted to abduct him, but it failed.
21 May	1535	As the civilian Isma‘il Zahra was tending to a herd of livestock on the outskirts of Shab‘a town, in the locality of Khallat al-Wasi‘ah–Jabal al-Shahl, an Israeli enemy foot patrol comprising eight personnel emerged from inside the occupied Shab‘a Farms and fired into the air in the direction of the herd, which was inside Lebanese territory. No one was injured in the incident.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
23 May	1550	As the civilian Qasim Zahrah was tending to a herd of livestock on the outskirts of Shab'a town, locality of Birkat al-Naqqar, opposite position C7-4, which is staffed by the Indian contingent of UNIFIL, a nine-person Israeli enemy that was inside the occupied Shab'a Farms fired two rounds towards Lebanese territory. No one was injured in the incident.
24 May	1420	As the civilian Isma'il Zahrah was tending to a herd of livestock on the outskirts of Shab'a town, in the locality of Sha'b al-Maqil-Jabal al-Shahl, an Israeli enemy patrol fired into the air in the direction of the herd. No one was injured in the incident.
28 May	0640 0800	Inside the occupied Shab'a Farms, on the perimeter of the Ruwaysat al-Alam position, two Merkava tanks were observed moving and the sound of several burst of medium and light weapon fire was heard.

The crew of the launch used loudspeakers to warn off a Lebanese fishing vessel and launched a noise bomb inside Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
4 May	1810	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a two-minute period, proceeding on its way for some 130 metres. The launch then left in the direction of occupied Palestinian territorial waters.
5 May	1834	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a two-minute period, proceeding on its way for some 185 metres. The launch then left in the direction of occupied Palestinian territorial waters.
8 May	2119	Opposite Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a five-minute period.
9 May	2100	Opposite Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a one-minute period.
11 May	0300	Opposite Ra's al-Naqurah, the Israeli enemy directed a searchlight from its Ra's al-Naqurah position towards Lebanese territorial waters for a one-minute period.
	0330	Opposite Ra's al-Naqurah, the Israeli enemy directed a searchlight from its Ra's al-Naqurah position towards Lebanese territorial waters for a one-minute period.
13 May	1813	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a one-minute period, proceeding on its way for some 200 metres. The launch then left in the direction of occupied Palestinian territorial waters.
15 May	0217	Opposite Ra's al-Naqurah, the Israeli enemy directed a searchlight from its Ra's al-Naqurah position towards Lebanese territorial waters for a two-minute period.
	0222	Opposite Ra's al-Naqurah, the Israeli enemy directed a searchlight from its Ra's al-Naqurah position towards Lebanese territorial waters for a two-minute period.
	0229	Opposite Ra's al-Naqurah, the Israeli enemy directed a searchlight from its Ra's al-Naqurah position towards Lebanese territorial waters for a one-minute period.

	0330	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 10-minute period, proceeding on its way for some 535 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 0402 hours, it violated the boundary again for a 73-minute period, proceeding on its way for some 515 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0415	Opposite Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a one-minute period.
	0739	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a four-minute period, proceeding on its way for some 295 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0955	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a three-minute period, proceeding on its way for some 204 metres. The launch then left in the direction of occupied Palestinian territorial waters.
18 May	0255	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 60-minute period, proceeding on its way for some 425 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0301	Opposite Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a one-minute period.
	0307	Opposite Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for an 18-minute period.
	0322	Opposite Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a 10-minute period.
	0348	Opposite Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a seven-minute period and sounded warning sirens.
19 May	1805	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a seven-minute period, proceeding on its way for some 200 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 1834 hours, it violated the boundary again for a six-minute period, proceeding on its way for some 500 metres. The launch then left in the direction of occupied Palestinian territorial waters.

	2128	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree 6433 (2011) for a four-minute period, proceeding on its way for some 55 metres. The launched fired three flares towards a Lebanese fishing vessel that was in Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
20 May	2005	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for an 11-minute period, proceeding on its way for some 407 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 2035 hours, it violated the boundary again for a 9-minute period, proceeding on its way for some 370 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	2040	Opposite Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launched a flare shell over Lebanese territorial waters.
22 May	1232	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 13-minute period, proceeding on its way for some 500 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	1336	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 29-minute period, proceeding on its way for some 425 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	1338	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 27-minute period, proceeding on its way for some 350 metres. The launch then left in the direction of occupied Palestinian territorial waters.
22 May	1416	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 20-minute period, proceeding on its way for some 500 metres. The launch then left in the direction of occupied Palestinian territorial waters.
