Land violations committed in June 2018

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
10 June	0900	Inside the occupied Shab‘a Farms, the Israeli enemy cleared and removed trees and bushes close to the side of the Birkat al-Naqqar road. The work was carried out by two excavators, two bulldozers and one road grader, which were accompanied by a patrol comprising 25 persons, 5 Defender vehicles and 4 black four-wheel drive vehicles that deployed along the location’s perimeter. At 1620 hours, the Israeli enemy finished its work and the bulldozers left in the direction of occupied territory. The excavators and the patrol remained near Birkat al-Naqqar.
11 June	0830	The Israeli enemy continued the work that it had begun on 10 June. Two trucks carrying barbed wire (concertina wire) unloaded their cargo at the location. They were accompanied by a patrol comprising approximately 20 persons and 5 Defender vehicles, which deployed along the location’s perimeter. At 1630 hours, the Israeli enemy finished its work and the bulldozers and the trucks left in the direction of occupied territory. The excavators and the patrol remained near Birkat al-Naqqar.
12 June	0900	The Israeli enemy continued the work that it had begun on 10 June. Using a crane truck, the enemy laid an 800-metre strip of barbed wire (concertina wire) along the side of the road. The enemy also erected a 20-metre long, 3-metre high earthen berm inside occupied territory, opposite Birkat al-Naqqar. A patrol comprising four Defender vehicles, one Hummer vehicle, two pickup trucks and approximately 30 persons was present as the work was being done. At 1800 hours, the Israeli enemy finished its work and the construction vehicles left towards occupied territory, but the patrol remained at the location.
13 June	0830	The Israeli enemy continued the work that it had begun on 10 June on the Birkat al-Naqqar road, inside the occupied Shab‘a Farms. The enemy cleared and removed brush using two excavators and one bulldozer. The construction vehicles were accompanied by a patrol comprising 4 Defender vehicles, 1 Hummer vehicle and approximately 30 persons that deployed along the location’s perimeter. At 1700 hours, the Israeli enemy finished its work and the bulldozers and the personnel left in the direction of occupied territory. The excavators and the above-mentioned patrol remained near Birkat al-Naqqar.
14 June	0900	The Israeli enemy continued the work that it had begun on 10 June on the Birkat al-Naqqar road, inside the occupied Shab‘a Farms. The enemy cleared and removed brush using two excavators and one bulldozer. The construction vehicles were accompanied by a patrol comprising 4 Defender vehicles, 1 Hummer vehicle and approximately 20 persons that deployed along the location’s perimeter. At 1600 hours, the Israeli enemy finished its work and the vehicles left in the direction of occupied territory.
	1150	On the outskirts of Shab‘a town, Jabal al-Shahl locality, enemy personnel inside the occupied Shab‘a Farms attempted to frighten, but not harm, the shepherd Mahir Hamdan, who was inside Lebanese territory, by firing shots into the air in his direction.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
15 June	1440	On the outskirts of Shab'a town, Jabal al-Shahl locality, near Birkat al-Naqqar, an Israeli enemy patrol seized a herd of goats (100 head) belonging to Khadrah Zahrah, and then drove the herd to the Radar post inside occupied territory. At 1800 hours, the Israeli enemy released the herd, which had been held at the Radar position, and the herd headed towards Shab'a town.
	2100 2115	The Israeli enemy fired three flare shells from the perimeter of its position inside the occupied Shab'a Farms.
19 June	0714	As the Norwegian People's Aid group was clearing landmines and cluster bombs in Wadi Qatmun locality, outside the town of Rumaysh, a landmine that had been planted previously by the Israeli enemy exploded, slightly injuring one person (his condition is not serious).
	0800	The Israeli enemy continued construction of an earthen berm 50 metres long and 3 metres high inside occupied Palestinian territory, near the Abu Dajajah north-west position and opposite the towns of Ramiya and Marwahin, points BP10, BP9 and AP334, and the Zar'it barracks north position. The work was carried out by two excavators that were accompanied by a civilian pickup truck and a Hummer vehicle. As one of the excavators was clearing brush, its boom crossed the technical fence and extended across the Blue Line by approximately 15 cm at point BP15, reaching as far as 2.15 m at point BP9. The Israeli enemy finished its work at 1600 hours.
21 June	1145	Inside occupied territory, opposite the town of Ramiya, the Israeli enemy pointed the cannon of a Merkava tank at an Observer Group Lebanon patrol and some very important persons from the United Nations Interim Force in Lebanon (UNIFIL) who were on the opposite side, inside Lebanese territory
22 June	0700	At Kafr Shuba-Hasbayya, near the Israeli enemy's Ruwaysat al-Alam position, a Lebanese Army patrol discovered a suspicious object, which was determined to be a spying system that the Israeli enemy had put in place previously to spy on Lebanese territory. Personnel from the army's engineering and signal corps were called in and a patrol belonging to the Indian contingent of UNIFIL arrived at the location. The army units proceed to dismantle the above-mentioned system.
	1300 1415	Explosions, the cause of which is unknown, were heard inside the occupied Shab'a Farms.
23 June	0800 1600	The Israeli enemy sent out foot patrols from the perimeter of the Ruwaysat al-Alam position, inside the occupied Shab'a Farms.
	0915	As the shepherd Muhammad Abdulazim (Syrian) was tending to a herd of livestock on the outskirts of Kafr Shuba, north of the Israeli enemy's Ruwaysat al-Alam position, opposite observation point OP5 of the Indian battalion of UNIFIL, an eight-person Israeli enemy foot attempted to abduct him, but failed. Four members of the patrol violated the line of withdrawal, entering some 20 m into Lebanese territory, and seized 200 head of livestock, which they held until 1045 hours. The Israeli enemy then released the herd, which returned in the direction of Lebanese territory.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
25 June	1810 1950	Several explosions were heard from inside the occupied Shab‘a Farms.
26 June	1500 1715	On the outskirts of the occupied northern part of the town of Ghajar and road B-14, the Israeli enemy started a fire that spread to the perimeter of position 28-4 of the Spanish battalion of UNIFIL, in the town of Abbasiyah. As the fire burned, a landmine that had been planted previously by the enemy exploded. Lebanese Army and civil defence personnel fought the fire, which was extinguished at 2100 hours, from inside liberated Lebanese territory. The fire did not spread beyond the line that separates the liberated parts of Lebanon from the occupied northern part of the Lebanese town of Ghajar. As a Lebanese Army patrol was documenting the work being done by the Israeli enemy inside occupied Palestinian territory opposite the Labbunah position, the members of a five-person Israeli enemy patrol began speaking in Arabic and threatened the Lebanese Army patrol by readying and pointing their weapons, but they did not open fire.
27 June	0615 1015	Several explosions were heard from inside the occupied Shab‘a Farms.
30 June	1430	As the shepherd Isma‘il Nasir was tending to a herd of livestock on the outskirts of Kafr Shuba town, south-west of the Ruwaysat al-Alam position, an Israeli enemy foot patrol consisting of eight persons accompanied by a Merkava tank attempted to abduct him, but failed to do so. He managed to avoid capture. The patrol then seized 85 goats and took them into occupied territory. At 1900 hours, the Israeli enemy returned 66 goats in Ruwaysat al-Alam locality. They returned the rest at 2000 hours.

In the course of the incursion, a noise bomb was detonated inside Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	1845	Off Ra’s al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a two-minute period, proceeding on its way for some 350 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	1845	Off Ra’s al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a three-minute period, proceeding on its way for some 60 metres. In the course of the incursion, a noise bomb was detonated inside Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.

3 June	1900	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for an eight-minute period, proceeding on its way for some 480 metres. The launch then left in the direction of occupied Palestinian territorial waters.
4 June	0320	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 30-minute period, proceeding on its way for some 460 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 0420 hours, the launch violated the boundary again for a 33-minute period, proceeding on its way for some 460 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0323	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a period of four minutes.
	0328	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a five-minute period.
	0340	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a one-minute period.
4 June	0430	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a 10-minute period.
	1832	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a three-minute period, proceeding on its way for some 200 metres. The launch then left in the direction of occupied Palestinian territorial waters.
5 June	0414	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a four-minute period, proceeding on its way for some 185 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 0429 hours, the launch violated the boundary again for a three-minute period, proceeding on its way for some 270 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 0624 hours, the launch violated the boundary a third time for a four-minute period, proceeding on its way for some 175 metres. The launch then left in the direction of occupied Palestinian territorial waters.
6 June	0339	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for an 11-minute period, proceeding on its way for some 600 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0531	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a nine-minute period, proceeding on its way for some 465 metres. The launch then left in the direction of occupied Palestinian territorial waters.

8 June	1830	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a three-minute period, proceeding on its way for some 130 metres. The launch then left in the direction of occupied Palestinian territorial waters.
10 June	0903	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 44-minute period, proceeding on its way for some 330 metres. The launch then left in the direction of occupied Palestinian territorial waters.
10 June	1904	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a two-minute period, proceeding on its way for some 200 metres. The launch then left in the direction of occupied Palestinian territorial waters.
11 June	0130	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a two-minute period.
	2110	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 30-minute period, proceeding on its way for some 585 metres. The launch then left in the direction of occupied Palestinian territorial waters.
14 June	0307	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 20-minute period, proceeding on its way for some 351 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0310	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for 30 seconds.
	0340	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 15-minute period, proceeding on its way for some 407 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0403	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 22-minute period, proceeding on its way for some 388 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0433	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a two-minute period, proceeding on its way for some 111 metres. The launch then left in the direction of occupied Palestinian territorial waters.

	1825	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a four-minute period, proceeding on its way for some 200 metres. The launch then left in the direction of occupied Palestinian territorial waters.
15 June	1832	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a three-minute period, proceeding on its way for some 220 metres. The launch then left in the direction of occupied Palestinian territorial waters.

The launch then left in the direction of occupied Palestinian territorial waters.

The launch then left in the direction of occupied Palestinian territorial waters.
23 June	0900	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 35-minute period, proceeded on its way for some 250 metres. In the course of the incursion, a bomb was hurled over Lebanese territorial waters and warning sirens were sounded. The launch then left in the direction of occupied Palestinian territorial waters.
	0930	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a 46-minute period, proceeding on its way for some 515 metres, and hurled a noise bomb towards a Lebanese fishing vessel. The launch then left in the direction of occupied Palestinian territorial waters.
24 June	0350	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a two-minute period.
	0730	Opposite Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch hurled an explosive device towards Lebanese territorial waters and broadcast in Hebrew over loudspeakers.

28 June	0403	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for 20 seconds.
	0415	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for a three-minute period, proceeding on its way for some 259 metres. The launch then left in the direction of occupied Palestinian territorial waters. The launch then left in the direction of occupied Palestinian territorial waters. 	0416	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch fired a flare shell towards Lebanese territorial waters.
	0452	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for a one-minute period and hurled an explosive device into those waters.
	0459	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch hurled an explosive device towards Lebanese territorial waters.

5 June	0920	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over the sea west of Naqurah. It circled over the North, Baalbek and Hirmil before leaving at 0015 hours on 6 June over Alma al-Sha'b.
