**Annex to the identical letters dated 21 December 2018 from the Permanent Representative of Lebanon to the United Nations addressed to the Secretary-General and the President of the Security Council**

**Land violations committed in November 2018**

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
1 November	1200–1300	Inside the occupied Shab‘a farms, Israel enemy Merkava tank movements were observed in the area around the Ruwaysat al-Alam post, accompanied by the sound of several explosions.
2 November	1130	Inside occupied Palestinian territory, near point B83, opposite the town of Kafr Killa, an engineering vehicle fitted with a surveillance camera approached and pointed the camera in the direction of Lebanese territory. At 1230 hours, the cameras were removed and the vehicle then left in the direction of occupied Palestinian territory.
6 November	0613	From inside occupied Palestinian territory, at Ibl al-Qamh, opposite the town of Sarda, an Israeli enemy patrol pointed a medium-calibre machine gun in the direction of post 64-9 of the Spanish UNIFIL contingent and in the direction of Lebanese territory.
7 November	0820	Inside the occupied Shab‘a Farms, from the Jabal al-Tayyarah post opposite the town of Kafr Killa, the Israeli enemy pointed a Merkava tank cannon in the direction of Lebanese territory.
	1100	Opposite the town of Kafr Killa, near point B82, an Israeli enemy Hummer vehicle approached. One of its crew directed 12.7 calibre weapon mounted on the vehicle in the direction of a Lebanese Army observation point. At 1115 hours, the vehicle left in the direction of occupied Palestinian territory.
	1230	Opposite the town of Mays al-Jabal, from inside occupied Palestinian territory between points B66 and B66 (1), an Israeli enemy patrol approached, consisting of a Poclair excavator escorted by a Defender vehicle, a Humvee and a civilian car. The excavator crossed the technical fence, violated the Blue Line, and started to clear brush over a 30-metre strip some five metres inside Lebanese territory. That was in the presence of a UNIFIL liaison unit team from inside occupied territory and another team from Lebanese territory. When a Lebanese Army patrol appeared on the scene, the enemy ceased its violation of the Blue Line and the excavator finished clearing the crossing along the technical fence inside occupied territory. At 1630 hours, the Israeli enemy finished its work and the vehicles left in the direction of occupied territory.
8 November	1910	From inside occupied Palestinian territory opposite the town of Kafr Killa, near point B83, eight Israeli enemy soldiers pointed 12.7 mm weapons in the direction of a Lebanese Army patrol while carrying out maintenance on the technical fence.
11 November	1200	From inside occupied Palestinian territory opposite the town of Kafr Killa, near point B84, while the Israeli enemy was performing various work and reinforcements on the separation wall, enemy soldiers deployed and shouted abusive language at passersby on the

		Lebanese side, while pointing their weapons in the direction of the Lebanese Army. In addition, a Merkava tank at the Jabal al-Tayyarah post pointed its cannon in the direction of Lebanese territory.
12 November	0730	From inside occupied Palestinian territory opposite Kafr Killa, near point B82, an Israeli enemy patrol stretched nylon between the separation fence and the technical fence for about 100 metres and spread gravel for about 200 metres. During the work, enemy soldiers pointed their weapons in the direction of a Lebanese Army observation point.
13 November	0830	Opposite Kafr Killa between points B82 and B83, an Israeli enemy soldier directed offensive gestures towards a Lebanese Army observation point.
	1100	Opposite Mays al-Jabal at point B68 members of an enemy patrol deployed in the area around the technical fence and cocked their personal weapons and medium-calibre weapons while pointing them in the direction of Lebanese territory and a Lebanese Army patrol.
	1220–1350	Inside the occupied Shab‘a Farms, the Israeli enemy sprayed medium- and light-calibre weapons fire at the area around the Fashkul and Zabdin posts.
14 November	0930	Opposite the town of Wazzani and UNIFIL point OP8, a Merkava tank pointed its cannon in the direction of Lebanese territory.
	1530	From inside occupied Palestinian territory opposite Labbunah at point B6, Israeli enemy soldiers pointed their weapons in the direction of a Lebanese Army observation point.
15 November	1500–1510	Several explosions were heard from inside the occupied Shab‘a Farms.
17 November	1230	At Saddanah, on the outskirts of the town of Shab‘a opposite the UNIFIL Indian contingent’s observation point OP3, an Israeli enemy foot patrol consisting of four soldiers attempted to abduct the herder As‘ad Hamdan without succeeding. They seized 50 goats and led them back into the occupied Shab‘a farms. At 1345 hours the entire herd was released back in the direction of Lebanese territory.
25 November	0830	From inside occupied Palestinian territory opposite the town of Kafr Killa, near point B83, two cement mixers and nine Israeli enemy workers approached and poured concrete between the separation wall and the technical fence along a 150-metre strip between points B83 and B83 (1). At 1427 hours, the chute of one of the cement mixers crossed over the Blue Line. At 1600 hours, the two cement mixers and the soldiers left in the direction of occupied territory.
	2000–2120	Inside the occupied Shab‘a Farms, the Israeli enemy launched six flares from inside the Radar position.
28 November	1630–1645	From inside the occupied Shab‘a Farms, the Israeli enemy sprayed light- and medium-weapons fire while an enemy helicopter flew overhead.

29 November	1235–1300	Explosions, sirens and emergency vehicles were heard from inside the occupied Shab‘a Farms.
30 November	0910	Inside occupied Palestinian territory, opposite Kafr Killa, an Israeli enemy patrol consisting of two pickups approached. Some 15 soldiers disembarked and proceeded to take photographs of Lebanese territory. Then they conducted a reconnaissance patrol between points B87 (2), and B90. At 0950 hours, they left in the direction of occupied territory.
	0930	At Musaylih/Nabatiyah, balloons were found with Hebrew writing on them.
