Land violations committed in June 2019

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
2 June	0750	<p>Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, to which a claim is maintained in that area.</p> <ul style="list-style-type: none">• At 0750 hours, a truck delivered a Bobcat vehicle, which the enemy operated behind the wall, opposite point M2.• At 0800, three workers separated and loaded boards that the Israeli enemy used as moulds for pouring concrete.• At 0840 hours, an excavator was used to continue digging a ditch from point M1 to point M2, in order to lay plastic pipes. The ditch was extended to approximately 100 m in length.• At 0930 hours, a ditch digger was used to carry out excavation work behind the gate at the border crossing east of point M1.• At 1020 hours, a Rapid vehicle and a car stopped at point M2, and enemy personnel carried out maintenance work on some cameras.• At 1600 hours, five workers assembled steel pipes into a tower-like structure behind the gate at the border crossing east of point M1. <p>The Israeli enemy finished its work at 1730 hours.</p>
	1057	<p>Inside occupied Lebanese territory, the Israeli enemy directed a camera located opposite point M2 for one minute towards a Lebanese Army post inside Lebanese territory.</p>
3 June	730	<p>An Israeli enemy patrol comprising five winches, five workers, a wheeled bulldozer, five soldiers and a vehicle equipped with a camera stopped opposite Naqurah, inside occupied Lebanese territory, south of point M1, and carried out the following work.</p> <ul style="list-style-type: none">• Erected a white and red, triangular metal tower, 8 m tall.• Installed a tracked platform equipped with a motor for raising and lowering the platform, so that a camera can be installed on it later.• Laid plastic pipes and buried them in the trench that had been previously dug west of point M2 and that extends to the platform onto which the metal tower had been attached. <p>The work ended at 1500 hours, and the patrol left in the direction of occupied territory.</p>

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
4 June	1005	<p>Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, to which a claim is maintained in that area.</p> <p>At 0900 hours, two Israeli enemy soldiers climbed the tower opposite point M1, in order to connect electricity.</p> <p>At 1005 hours, the steel platform attached to the wall east of point M2 was lowered so that an additional camera could be installed onto it. At 1015 hours, the steel platform was returned to its former position. At 1020 hours, the Israeli enemy finished its work and the vehicles headed towards occupied territory.</p>
	1030	<p>On the outskirts of the town of Mays al-Jabal, opposite points B68 and B68 (1), inside Lebanese territory, a fire broke out across some 25,000 m² of scrub land, causing seven landmines that had been left behind by the Israeli enemy to explode.</p>
6 June	1300 1400	<p>Explosions, the cause of which is unknown, were heard inside the occupied Shab'a Farms.</p>
	2030	<p>From inside occupied Palestinian territory, opposite the outskirts of the town of Blida, at point BP29, the Israeli enemy started a fire that eventually engulfed some 1,500 m² of scrub land inside Lebanese territory. The fire was extinguished by the Lebanese Civil Defence.</p>
7 June	1030	<p>From inside the occupied Shab'a Farms, near the Ramta outpost of the Israeli enemy, the sound of medium machine-gun fire was heard. The firing stopped at 1050 hours.</p>
8 June	0800	<p>An Israeli enemy patrol comprising a Hummer vehicle equipped with a machine gun and a Defender vehicle stopped inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, and a patrol member pointed the machine gun towards Lebanese territory. The patrol left in the direction of occupied territory at 0830 hours.</p>
	1210	<p>Inside occupied Palestinian territory, opposite the town of Rumaysh, six Israeli enemy personnel pointed their firearms at a Lebanese Army patrol.</p>
9 June	1100	<p>An Israeli enemy patrol comprising a Hummer vehicle equipped with a machine gun stopped inside occupied Palestinian territory, near point TP37, and a patrol member pointed the machine gun towards Lebanese territory. The patrol left in the direction of occupied territory at 1430 hours.</p>
10 June	0800	<p>Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, to which a claim is maintained in that area. The Israeli enemy used a JCB wheeled bulldozer to dig a 30 m trench between points M1 and M1(1). Opposite the Israeli enemy's post east of the Dikiyah Gate, opposite Ra's al-Naqurah, a bulldozer was used to carry out excavation work. The bulldozer was then moved west of point M2, where it was used carry out excavation work and lay plastic pipe. The work ended at 1630 hours.</p>

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
11 June	1030	Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, to which a claim is maintained in that area. An excavator was used to continue digging a trench between points M1 and M1(1), lay plastic pipe and place boards, to be used later for pouring concrete. As the work was being carried out, a Merkava tank and a vehicle equipped with a surveillance camera were positioned inside the Israeli enemy's Dikiyah Gate east position.
12 June	0845	Inside occupied Lebanese territory, on the Abbasiyah road, between the enemy's Ayn al-Tinah and Fashkul outposts, the Israeli enemy excavated earth and cleared brush near the barbed wire fence. The enemy also brought earth from occupied territory and laid it on both sides of the aforementioned road, with a view to restoring its condition. The work was carried out using two Poclairn vehicles, three bulldozers and one truck. Those vehicles were escorted by a hostile patrol comprising 15 persons, who deployed themselves on the perimeter of the work area. The work ended at 1630 hours and the patrol left in the direction of occupied territory.
	0930	An Israeli enemy patrol comprising a Hummer vehicle equipped with a machine gun stopped inside occupied Palestinian territory, opposite the town of Wazzani, near point BP38(2), and a patrol member pointed the machine gun towards Lebanese territory. The patrol left in the direction of occupied territory at 1030 hours.
	1530	As the civilian Isma'il Dali and the Syrian national Muhammad Kamal Bur'i were tending to a herd of goats on the outskirts of the town of Shab'a, in Shaghur al-Tawil district, north-east of the Israeli enemy's Radar position, an enemy foot patrol directed weapon fire and hurled a smoke bomb at them. The herd returned, but the shepherds did not. At 2140 hours, the Lebanese Army liaison unit received a communication from the head of the liaison unit of the United Nations Interim Force in Lebanon (UNIFIL) confirming that the Israeli enemy had abducted the shepherds in the aforementioned area and was interrogating them. At 1505 hours on 13 June, opposite Ra's al-Naqurah, the shepherds were handed over to the Lebanese Army by the UNIFIL liaison unit.
	1605	An Israeli enemy patrol comprising two GMC vans and a Hummer vehicle, escorted by a Merkava tank, stopped inside Palestinian territory, opposite points B64 and B65, whereupon some 15 personnel and a dog alighted from the vehicles. In addition, the tank's cannon was pointed towards a Lebanese Army patrol. The patrol left in the direction of occupied territory at 1840 hours.
	1720 1840	Explosions, the cause of which is unknown, were heard inside the occupied Shab'a Farms.
13 June	0800	Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, to which a claim is maintained in that area. Workers in civilian clothing used a concrete mixer and a pump to pour concrete opposite point M1(1), near the enemy's border gate (the yellow gate). A wheeled bulldozer was used to carry out excavation work near the aforementioned gate and to level the dirt road west of point M2. The work ended at 1600 hours, and the vehicles and the personnel left in the direction of occupied territory.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	1000 1130	Several explosions were heard inside the Shab'a Farms as military aircraft flew overhead.
	1120	An Israeli enemy patrol comprising a Poclair and a Hummer vehicle stopped inside occupied Palestinian territory, opposite the Abbasiyah mosque. Three patrol members alighted from the vehicles and cleared dirt near the technical fence. One patrol member pointed his weapon towards a Lebanese Army patrol.
14 June	1055	Inside occupied Palestinian territory, opposite point OP3 Shab'a, the Israeli enemy pointed the cannon of a Merkava tank towards Lebanese territory.
16 June	0800	<p>Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, to which a claim is maintained in that area. The enemy brought a concrete mixer and a bulldozer to that area and used them to do the following.</p> <ul style="list-style-type: none"> • Pour a concrete supporting wall extending to the east from point M1 at the enemy's border gate. • Level the dirt road that had been cleared earlier between point M1 east and point M2 west. <p>The work ended at 1600 hours, and the bulldozer and the concrete mixer were taken to occupied territory.</p>
	2130	Several explosions were heard inside the occupied Shab'a Farms. It is likely that the Israeli enemy army was carrying out exercises.
17 June	0800	<p>Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, to which a claim is maintained in that area. The enemy carried out the following work.</p> <ul style="list-style-type: none"> • At 0800 hours, two workers separated boards opposite point M1(1). • At 1055 hours, an excavator was used to clear refuse and dirt. At 1200 hours, the excavator was used to transport boards into occupied territory. <p>The work ended at 1700 hours.</p>
	0940 1255	Inside the occupied Shab'a Farms, several explosions and bursts of medium-weapon fire were heard.
18 June	1400	Inside occupied Palestinian territory, opposite Ra's al-Naqurah, nine Israeli enemy personnel pointed their firearms at Lebanese Army personnel.
20 June	0900	Several explosions were heard from inside the occupied Shab'a Farms.
	1100 1530	A fire broke out as a Mine Action Group team was detonating a landmine on the outskirts of the town of Blida, between points B61 and B61(1). The fire, which covered some 2 dunums, detonated 29 landmines that had been left behind inside Lebanese territory by the Israeli enemy, but no one was injured.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
21 June	0900 1030	Gunfire was heard inside occupied Palestinian territory at the Israeli enemy's Shaykh Abbad position, opposite the town of Hula. Some bullets passed over the members of a Mine Action Group demining team who were working on the outskirts of the town, which is inside Lebanese territory, and caused them to stop their work.
	1600	A group of four vehicles belonging to the Israeli enemy stopped in occupied Palestinian territory, opposite point B55. Some 30 civilians alighted from the vehicles and used their phones to observe and capture images of Lebanese territory. They left in the direction of occupied territory at 1700 hours.
22 June	1425 1445	Inside occupied Palestinian territory, opposite Ra's al-Naqurah, an Israeli enemy soldier pointed a light weapon towards Lebanese Army personnel and journalists.
23 June	1230	In occupied Lebanese territory (Ra's al-Naqurah), an Israeli enemy army soldier, accompanied by two members of the UNIFIL liaison unit, stopped at point M1 and photographed a Lebanese tanker.
	1340	Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, to which a claim is maintained in that area. An enemy bulldozer placed a concrete guardhouse next to the metal tower that the enemy had erected opposite point M1, near the enemy's border gate.
	1700	In occupied Lebanese territory (Ra's al-Naqurah), an Israeli enemy soldier changed the camouflage netting on the emplacements from point M2 to point M1 before leaving at 1740 hours and heading to occupied territory.
	2200 2235	Several explosions, interspersed with the sound of enemy helicopters, were heard inside the occupied Shab'a Farms.
24 June	0720	An Israeli enemy patrol comprising two Hummer vehicles stopped inside occupied Palestinian territory opposite the town of Udaysah, near point TP37. Five personnel in military garb alighted from the vehicles and pointed their weapons towards Lebanese territory. The patrol left in the direction of occupied territory at 0800 hours.
	0800	Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, to which a claim is maintained in that area. A bulldozer was used to dig a trench behind the enemy's border gate, opposite point M1. The work ended at 1600 hours.
	0830	Inside Palestinian territory, opposite the town of Udaysah, near point TP37, an Israeli enemy soldier pointed a machine gun towards Lebanese territory.
25 June	0900	Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, to which a claim is maintained in that area. A bulldozer was used to continue digging a trench behind the enemy's border gate. The work ended at 1600 hours.
	1320	Opposite Naqurah, at the Lebanese-Palestinian border, an Israeli enemy officer spoke in Arabic to Lebanese Army personnel.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	1400	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, an Israeli enemy soldier pointed a machine gun towards Lebanese territory.
	1415	An Israeli enemy patrol comprising a Defender vehicle and a van stopped in occupied Palestinian territory, opposite point TP16 and the town of Rumaysh. Ten enemy personnel alighted from the vehicles and installed a pole south of the technical road. They then mounted a camera atop the pole and pointed it towards Lebanese territory.
26 June	0750	<p>Opposite the town of Udaysah, the Israeli enemy carried out the following work.</p> <p>At 0750 hours, in occupied Palestinian territory, near point TP37, the Israeli enemy began moving earth using two trench diggers and two bulldozers. At 0930 hours, some earth and stones spilled into occupied Lebanese territory. The work ended at 1430 hours, and the vehicles left in the direction of occupied territory.</p> <p>At 0930 hours, the Israeli enemy used a trench digger to move earth near point TP36(2), inside occupied Lebanese territory. The work ended at 1230 hours, and the trench digger left in the direction of occupied territory.</p>
	0815	Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, to which a claim is maintained in that area. A bulldozer was used to continue digging a trench behind the enemy's border gate and to lay plastic pipe in the trench.
	1250	A fire broke out as the Norwegian People's Aid demining group was detonating landmines at Wadi Sa'sa', opposite points BP15 and TP16. The fire covered some 3,000 m ² of dry scrub land, spreading as far as the Blue Line and into occupied Palestinian territory, and detonated 27 landmines that had been left behind by the Israeli enemy in Lebanese territory.
	1730	The Israeli enemy set ablaze a 500 m ² area of dry scrub land opposite the town of Abbasiyah al-Ghajar, inside occupied Lebanese territory, causing two landmines that had been left behind by the Israeli enemy to explode.
	2140	From inside occupied Palestinian territory, opposite Ra's al-Naqurah, the Israeli enemy directed a searchlight towards Lebanese territory for one minute.
27 June	0810	Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, to which a claim is maintained in that area. A wheeled bulldozer and an excavator were used to dig channels behind the enemy's border gate (the yellow gate) and lay plastic pipe in those channels. Those pipes were then connected using three shafts and concrete was poured into the channels. As that work was being done, enemy personnel pointed a MAG machine gun towards Lebanese Army personnel from 1330 to 1405 hours. The work ended at 1530 hours, and the vehicles left in the direction of occupied territory.
	0830	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, an Israeli enemy soldier pointed a machine gun towards Lebanese territory.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	1330	A fire broke out as the Danish company DCA was detonating mines in Birkat Rishah district, opposite points 273AP and B22(3). The blaze, which covered some 400 m ² of dry scrub and trees, detonated six landmines that had been left behind by the Israeli enemy in Lebanese territory. Members of the Lebanese Civil Defence fought the fire, which was extinguished at 1630 hours.
30 June	0800	Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, to which a claim is maintained in that area. A wheeled bulldozer was used to excavate earth from an area west of point M2 and westwards as far as point M1(1). The enemy used a concrete mixer to pour concrete into trenches that it had dug previously behind the border gate (the yellow gate) opposite point M1. Meanwhile, enemy personnel filled sandbags and placed them atop the concrete emplacements located west of point M2. The work was completed 1600 hours.
	1430	Opposite the town of Blida, between points B58(1) and B59, a fire broke out inside occupied Palestinian territory and extended into Lebanese territory, detonating 11 landmines that had been left by the Israeli enemy inside Lebanese territory. Lebanese Civil Defence personnel extinguished the fire at 1800 hours.

2 June	0050	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters: <ul style="list-style-type: none"> • For one minute at 0050 hours; • For eight minutes at 0052 hours; the vessel's crew sounded warning sirens and broadcast over loudspeakers in Hebrew; • For one minute at 0125 hours.
	1809	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for four minutes, proceeding on its way for some 185 metres. The launch then left in the direction of occupied Palestinian territorial waters.

The launch then left in the direction of occupied Palestinian territorial waters. • For five minutes at 1030 hours, proceeding on its way for some 351 metres. The launch then left in the direction of occupied Palestinian territorial waters.
5 June	0850	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for one minute, proceeding on its way for some 100 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0853	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for 23 minutes, proceeding on its way for some 480 metres. The launch then left in the direction of occupied Palestinian territorial waters.
6 June	0620	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for 20 minutes, proceeding on its way for some 120 metres. 	1542	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for two minutes, proceeding on its way for some 205 metres. The launch then left in the direction of occupied Palestinian territorial waters.
10 June	0354	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for 21 minutes, proceeding on its way for some 410 metres. The launch then left in the direction of occupied Palestinian territorial waters.
