Land violations committed in July 2019

| <i>Date</i> | <i>Time</i> | <i>Nature of violation</i> |
|-------------|-------------|--|
| 1 July | 0800 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, in the area to which Lebanon maintains a claim. The enemy cleared brush surrounding the emplacements and installed camouflage netting on the emplacements west of point M2, and continuing west as far as point M1(1). Work ended at 1830 hours. |
| | 0800 | From inside occupied Palestinian territory, opposite the town of Blida, the Israeli enemy carried out the following hostile acts: <ul style="list-style-type: none">– At 0800 hours, while the enemy used a steamroller and two trench diggers to clear and repair the dirt road between points BP28(1) and B60(1), the boom of a digger crossed the technical fence and the Blue Line several times opposite point BP28. Two excavators repaired the earthen berm. Work ended at 1500 hours.– At 1115 hours, opposite point BP28, a patrol comprising a Hummer vehicle and a trench digger crossed the technical fence, and its boom crossed the Blue Line. The digger began to clear brush. When a Lebanese Army patrol arrived to observe the violation, the soldiers operating the excavator dumped soil on them. One of the enemy soldiers also lit a fire that spread into Lebanese territory across 20 dunams of dry brush and olive trees. The fire was extinguished at 1450 hours. |
| | 1130 | From inside occupied Palestinian territory opposite the town of Ayta al-Sha‘b, an Israeli enemy Merkava tank pointed its cannon towards the Lebanese Army observation point and Lebanese territory. |
| 2 July | 1020 | From inside occupied Lebanese territory, in Ra’s al-Naqurah, an Israeli enemy delegation consisting of five members in civilian clothing and a young woman in military uniform conducted a reconnaissance patrol from point M1(1) eastwards as far as the area west of point M2 on the military dirt road alongside the technical fence. At 1700 hours, they left and headed towards occupied territory. <ul style="list-style-type: none">– Opposite the town of Udaysah, between points TP36(2) and TP37, Israeli enemy soldiers carried out construction work inside occupied Lebanese territory. They installed steel rods and connected them to one another with barbed wire. They also dumped quantities of gravel, steamrolled it and levelled it. |
| 3 July | 0800 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, in the area to which Lebanon maintains a claim. The Israeli enemy used a crane and a winch to weld a steel net to steel pillars at a height of four metres and across a length of some 25 metres starting from point M1(1) eastwards along the inside of the technical fence. The technical fence was removed along a distance of some 50 m behind the steel door opposite point M1. |

| | 1200 | From inside occupied Palestinian territory opposite the town of Rumaysh, an Israeli enemy Merkava tank pointed its cannon towards the Lebanese Army observation point and Lebanese territory. |
| | 1310 1430 | While the Israeli enemy was clearing brush and trees opposite point B59 (Blida), in occupied Palestinian territory, soldiers trained a 12.7 mm calibre machine gun affixed to a Humvee vehicle on a Lebanese Army patrol that was observing the work in the presence of a patrol of the Nepalese unit of the United Nations Interim Force in Lebanon (UNIFIL). |
| | – | Opposite the town of Udaysah, between points TP36(2) and TP37, Israeli enemy soldiers carried out construction work inside occupied Lebanese territory. They installed steel rods and connected them to one another with barbed wire. They also dumped quantities of gravel, steamrolled it and levelled it. |
| 4 July | 0750 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, in the area to which Lebanon maintains a claim. The Israeli enemy used a crane and a winch to install steel pillars and affix a steel net over them, starting from point M1(1) eastwards. Barbed wire was installed on the outside. The 50 metres of technical fence that had been removed behind the steel gate opposite point M1 were then reinstalled. |
| 6 July | 2045 | Opposite the town of Blida between points BP28 and BP29, inside Palestinian territory, the Israeli enemy lit a fire that spread into Lebanese territory across 1,000 m ² of dry brush. |
| 7 July | 0740 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, in the area to which Lebanon maintains a claim. The enemy continued to use a crane, a winch and a trench digger to install steel pillars eastwards from point M1 and affix barbed wire to the pillars. Work ended at 1715 hours. |
| | 1000 | Opposite points B58(1) and B59(1) and the town of Blida, inside occupied Palestinian territory, the Israeli enemy cleared and repaired the dirt road using a trench digger and an excavator, without crossing the technical fence or the Blue Line. The machines were escorted by a Humvee vehicle on which a 12.7 mm calibre machine gun had been installed. A member of the patrol trained the machine gun on a Lebanese Army patrol. Work ended at 1550 hours. The digger and the excavator remained in place, and the Humvee returned into occupied territory. |
| | 1100 | Opposite the town of Blida, the boom of a Poclain excavator that was being used by the Israeli enemy to clear the technical fence crossed the Blue Line, entering the Lebanese side by some 3 metres. |
| | – | An Israeli enemy patrol approached opposite the towns of Yarun and Marun al-Ra's, in occupied Lebanese territory, and cleared and removed brush and soil. |
| | – | Opposite the town of Udaysah, between points TP36(2) and TP37, Israeli enemy soldiers carried out construction work inside occupied Lebanese territory. They installed steel rods and connected them to one another with barbed wire. They also dumped quantities of gravel, steamrolled it and levelled it. |

| 8 July | 0730 | <p>Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, in the area to which Lebanon maintains a claim. The enemy took the following actions:</p> <ul style="list-style-type: none">– The enemy continued to use a crane and a winch to install steel pillars and weld a steel net to it from point M1(1) eastwards. At 1025 hours, while the net was being welded, a spark hit Lebanese territory north of the technical fence, lighting a fire that spread across 1 m². Israeli enemy soldiers extinguished the fire from inside occupied territory using a hose.– Three soldiers belonging to the enemy army welded steel pipes on the eastern emplacement of the hostile position at Ra's al-Naqurah.– Barbed concertina wire was installed on the north side of the steel fence east of point M1(1). <p>Two individuals in civilian clothing photographed the tower installed by the Lebanese Army on the Lebanese side in the town of Naqurah.</p> <p>Work ended at 2000 hours, and the vehicles and the personnel left in the direction of occupied territory.</p> |
| | 0730 | <p>An Israeli enemy patrol consisting of a Humvee vehicle mounted with a machine gun approached near point TP37 opposite the town of Udaysah, inside occupied territory. One of the soldiers trained the weapon on Lebanese territory. The patrol left in the direction of occupied territory at 1430 hours.</p> |
| | 0900 | <p>Opposite the towns of Yarun and Marun al-Ra's, in occupied Lebanese territory, an Israeli enemy Poclair excavator patrol approached and cleared brush from point B50 to the area west of point BP21(1). The patrol left in the direction of occupied territory at 1200 hours.</p> |
| | 2200 2300 | <p>From inside the occupied Shab'a Farms, the Israeli enemy launched three flares over the Radar position.</p> <ul style="list-style-type: none">– Opposite the town of Udaysah, between points TP36(2) and TP37, Israeli enemy soldiers carried out construction work inside occupied Lebanese territory. They installed metal rods and connected them to one another with barbed wire. They also dumped quantities of gravel, steamrolled it and levelled it. |
| 9 July | 0800 | <p>Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, in the area to which Lebanon maintains a claim. The enemy took the following actions:</p> <ul style="list-style-type: none">– Steel pillars were installed eastwards from point M1(1) and a steel net was welded to them.– Camouflage netting was installed on the emplacement inside the hostile position of Ra's al-Naqurah.– An Israeli enemy patrol approached opposite the towns of Yarun and Marun al-Ra's, in occupied Lebanese territory, and cleared and removed brush and soil. |

| | – | Opposite the town of Udaysah, between points TP36(2) and TP37, Israeli enemy soldiers carried out construction work inside occupied Lebanese territory. They installed metal rods and connected them to one another with barbed wire. They also dumped quantities of gravel, steamrolled it and levelled it. |
| 10 July | 1615 | Opposite the town of Ra's al-Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory. Barbed concertina wire was installed north of the emplacements at the hostile position of Ra's al-Naqurah. Work ended at 1815 hours. |
| | – | Israeli enemy soldiers carried out construction work opposite the town of Udaysah, between points TP36(2) and TP37 inside occupied Lebanese territory. They installed metal rods and connected them to one another with barbed wire. They also dumped quantities of gravel, steamrolled it and levelled it. |
| 11 July | 1140 | Opposite the town of Ra's al-Naqurah, the Israeli enemy trained a MAG machine gun on Lebanese Army soldiers. |
| | 1210 | Opposite the town of Ra's al-Naqurah, at the Lebanese-Palestinian border, the Israeli enemy used a JCB excavator to continue with construction work inside occupied Lebanese territory and remove brush. Work ended at 1515 hours. |
| 14 July | 0900 | Opposite the town of Ra's al-Naqurah, at point M1, the Israeli enemy continued with construction work inside occupied Lebanese territory and carried out maintenance on the steel netting. Work ended at 1600 hours. |
| 15 July | 0850 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, in the area to which Lebanon maintains a claim. From point M1(1) eastward, workers in civilian clothing installed wooden planks on the bases of the steel pillars that had previously been installed, with a view to coating them with concrete. Three Israeli enemy soldiers and two members of the UNIFIL liaison unit travelled from point M1 to the hostile position of Ra's al-Naqurah. They photographed the tower that the Lebanese Army had been installing and the maintenance activities that were being carried out by the enemy. Work ended at 1600 hours, and the workers left in the direction of occupied territory. |
| | 1230 | Opposite the town of Udaysah, inside occupied Lebanese territory, north of point TP36, along the Blue Line in an area to which Lebanon maintains a claim, an Israeli enemy patrol comprising a crane and two workers appeared and worked on installing a metal fixture atop a cement wall. At 1430 hours, work ended, and the patrol left in the direction of occupied territory. |
| | 1245 | Opposite the town of Rumaysh, the Israeli enemy pointed the cannon of a Merkava tank at Lebanese Army soldiers. |
| | 1420 | Opposite point B67(1) (Mays al-Jabal), in occupied Palestinian territory, an Israeli enemy patrol trained a weapon that was affixed to a Hummer vehicle on Lebanese Army soldiers for five minutes. |
| | 1800 1945 | Several explosions were heard from inside the occupied Shab'a Farms. |

| | 1240 | From inside occupied Palestinian territory, opposite the town of Aytarun and point B55(1), enemy soldiers trained their weapons for five minutes at the aforementioned patrol. |
| 16 July | 0700 | An Israeli enemy patrol consisting of 25 soldiers and a dog approached from inside occupied Palestinian territory, opposite point BP15 (Rumaysh). The patrol crossed the technical fence without crossing the Blue Line and inspected the area. At 0930 hours, the patrol left in the direction of the hostile position of Khillat al-Budiyah. It was escorted by a Merkava tank from within the Jabal al-Tayyarat position, which pointed its cannon at a Lebanese Army patrol. The patrol left in the direction of occupied territory at 1840 hours. |
| | 0900 | Two cranes and four Israeli Army workers approached on occupied Lebanese territory between points TP36 and TP36(1) on the Blue Line in the area to which Lebanon maintains a claim. They installed a steel fence over the steel netting stretched over the cement wall. Work ended at 1300 hours, and the workers left in the direction of occupied territory. |
| 17 July | 0900 | A crane and two Israeli Army workers approached occupied Lebanese territory between points TP36(1) and TP36(2) on the Blue Line in the area to which Lebanon maintains a claim. They installed a steel fence over the steel netting stretched over the cement wall. At 1230 hours, work ended and the workers left in the direction of occupied territory. |
| | 0945 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, in the area to which Lebanon maintains a claim. Workers in civilian clothing used a Poclair excavator and a crane to move steel frames that had previously been welded east of the hostile position of Ra's al-Naqurah, and installed two of them east of point M1(1). Work ended at 1915 hours, and the workers left in the direction of occupied territory. |
| | 1800 1925 | Several explosions were heard from inside the occupied Shab'a Farms. |
| 18 July | 0800 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of points M1 and M2 along the Blue Line, in the area to which Lebanon maintains a claim. A concrete mixer was used to spread concrete on the steel fence that had previously been assembled east of point M2. Black plastic pipes were installed behind the gate of the enemy border crossing (the yellow gate) opposite point M1. Work ended at 1600 hours. |
| | 0900 | A crane and two Israeli Army workers approached on occupied Lebanese territory opposite the town of Udaysah, between points TP36(1) and TP36(2) on the Blue Line in the area to which Lebanon maintains a claim. They installed a steel fence over the steel netting at the top of the cement wall. At 1330 hours, work ended and the two workers and crane left in the direction of occupied territory. |

| | 0850 | <p>While Israeli enemy civilian workers were welding steel netting to the cement wall opposite the town of Naqurah, a spark landed in Lebanese territory and caused a fire that spread some 50 m into Lebanese territory across a length of 100 metres parallel with the wall, westward from point M2. Lebanese civil defence extinguished the fire at 1045 hours.</p> <p>At 1150 hours, the fire flared up again, consumed four dunams of dry brush, and detonated a landmine that had been left by the Israeli enemy, without hurting anyone. Lebanese civil defence extinguished the fire at 1545 hours.</p> |
| 19 July | 0900 | At point M1, opposite the town of Ra's al-Naqurah, the Israeli enemy carried out construction work inside Lebanese territory and renovated the cement guardhouse. Work ended at 1030 hours. |
| 21 July | 0730 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, in the area to which Lebanon maintains a claim. Workers in civilian clothing used a crane to install steel frames mounted with steel netting and barbed concertina wire. They also used a concrete mixer and pump to coat the bases with concrete. Work ended at 1800 hours. |
| | 1830 | An Israeli enemy patrol consisting of a Humvee vehicle approached between points BP22 and B52 (Marun al-Ra's), in occupied Palestinian territory. Two soldiers stepped out and inspected the technical fence. A member of the hostile patrol trained a 12.7 mm calibre machine gun at a Lebanese Army patrol. The patrol left at 1840 hours in the direction of occupied territory. |
| | 2120 | Opposite the town of Ra's al-Naqurah, the Israeli enemy directed a searchlight towards occupied Lebanese territory for one minute. |
| 22 July | 0800 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, in the area to which Lebanon maintains a claim. Workers in civilian clothing continued assembling a separation fence, using a crane to install five steel cubes mounted with steel netting and barbed concertina wire. They also used a concrete mixer and pump to coat the some of the bases with concrete. Work ended at 1600 hours. |
| 23 July | 0730 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, in the area to which Lebanon maintains a claim. East of point M1(1), soldiers continued to use a crane to install nine 4x4m steel frames mounted with steel netting and barbed concertina wire. They also used a concrete mixer and pump to coat the bases with concrete. The enemy finished installing the separation fence and connected it with the cement wall opposite Ra's al-Naqurah. Work ended at 1800 hours. |
| | 1320 | Four civilian cars approached point TP31(1) from inside occupied Palestinian territory, opposite the town of Udaysah. Fifteen individuals in civilian clothing stepped out, began a reconnaissance patrol in the area and took pictures of the Lebanese side. At 1340 hours, they left in the direction of occupied territory. |
| | 1715 1810 | From inside the Rumaysh Gate position in occupied Palestinian territory, opposite the town of Rumaysh, the Israeli enemy pointed the cannon of a Merkava tank at Lebanese territory and Lebanese Army soldiers. |

Workers continued to weld together steel frames that had previously been assembled eastwards from point M1(1). They also installed a pedestrian gate some 2 metres tall and 1 metre wide in the steel separation fence. Work ended at 1745 hours. |
| | 1200 1240 | Several explosions were heard from inside the occupied Shab'a Farms. The cause was not ascertained. |
| | 1620 | An Israeli enemy patrol comprising two Humvee vehicles, one of them mounted with a machine gun, took up positions inside occupied Palestinian territory, in the surroundings of point TB37 (Udaysah), and trained the weapon on Lebanese territory. The patrol left in the direction of occupied territory at 1640 hours. |
| 25 July | 1000 | An Israeli enemy patrol comprising a Hummer vehicle mounted with a machine gun, in addition to a Defender vehicle, took up positions inside occupied Palestinian territory opposite Sahl al-Khiyam, near point B91, and trained the weapon on Lebanese territory. The patrol left in the direction of occupied territory at 1030 hours. |
| 28 July | 1100 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, in the area to which Lebanon maintains a claim. Workers in civilian clothing installed control devices in the cement room at the foot of the steel tower that had previously been installed behind the border crossing gate. They also installed four cameras on the tower. Ten individuals in military uniform, along with three individuals in civilian clothing, undertook a reconnaissance patrol west of point M2, in the direction of point M1, behind the steel separation fence that had previously been installed. Work ended at 1915 hours. |
| 29 July | 0800 | Opposite the town of Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory south of point M1 along the Blue Line, in the area to which Lebanon maintains a claim. The enemy continued to programme and install control devices for cameras that had been assembled on the steel tower opposite point M1. Work ended at 1800 hours. |
| 30 July | 2200 2240 | From inside the occupied Shab'a Farms, the Israeli enemy launched flares over the Radar position. |

| 2 July | 0820 | <p>Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for seven minutes, proceeding on its way for some 335 metres. | | 0830 | <p>Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for 10 minutes, proceeding on its way for some 100 metres.
