Land violations committed in May 2022

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
2 May	1000	In occupied Palestinian territory, opposite the town of Udaysah, near points TP36 and TP37, two Israeli enemy tanks pointed their cannons in the direction of Lebanese territory.
	1335	In occupied Lebanese territory, opposite the town of Udaysah and point TP36, an Israeli enemy patrol consisting of 31 personnel in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point as far as point TP35. They pointed their weapons towards Lebanese army personnel. Meanwhile, a Merkava tank deployed near point TP36(2) pointed its cannon towards Lebanese territory.
3 May	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 10 personnel in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point as far as point TP37. Then several of the patrol members opened the iron gate in the technical fence. Five of them took up positions inside the emplacement located at the spot while the five others took up positions on the dirt road and pointed their weapons towards Lebanese territory.
4 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Mays al-Jabal, 10 in Naqurah and 4 in Alma al-Sha‘b.
	0800	Opposite the town of Marwahin at point M4, while a Lebanese army patrol was conducting a patrol on the Lebanese border with occupied Palestine, it emerged that Israeli enemy personnel had installed a metal pole at the vehicle gate with two remote control cameras that they pointed towards Lebanese territory.
5 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 4 in Mays al-Jabal, 20 in Naqurah and 5 in Alma al-Sha‘b.
	1000	In occupied Palestinian territory, opposite the town of Kafr Kila at the Israeli enemy Jabal al-Tayyarah position, a group of 30 individuals in civilian dress approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1050 hours.
6 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 15 in Naqurah, 5 in Alma al-Sha‘b, 27 in Marwahin and 12 in Duhayrah.
	0035	In the Israeli enemy position opposite the town of Ayta al-Sha‘b, Israeli enemy soldiers fired a flare that landed in Lebanese territory.
7 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 30 in Marwahin and 13 in Duhayrah.

	1915	In Lebanese territory, opposite point BP12, while several Lebanese farmers were in their fields, a hostile patrol consisting of four Humvee vehicles approached. One of its members threw a smoke bomb towards the farmers to drive them away. It landed between the technical fence and the Blue Line without crossing it. At 2015 hours, Israeli enemy soldiers fired four flares, all of which crossed the Blue Line and landed inside Lebanese territory. Between 2350 hours and 2359 hours, enemy Israeli soldiers fired two flares that crossed the Blue Line and landed inside Lebanese territory.
9 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Mays al-Jabal, 12 in Naqurah, 8 in Alma al-Sha‘b, 11 in Marwahin and 7 in Duhayrah.
	0740	In occupied Palestinian territory, opposite the town of Maysat, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 0845 hours.
	1300 1500	Several explosions and bursts of weapons fire of unknown origin were heard from inside the occupied Shab‘a Farms.
10 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 18 in Naqurah, 5 in Alma al-Sha‘b, 23 in Yarun, 42 in Marwahin, 5 in Duhayrah and 15 in Hula.
	1600	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy Merkava tank positioned itself behind an earthen berm and pointed its cannon towards Lebanese territory. The tank left in the direction of occupied territory at 1630 hours.
	1715	In occupied Palestinian territory, opposite the town of Mays al-Jabal, five Israeli enemy soldiers pointed their weapons towards Lebanese territory until 1900 hours.
11 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 4 in Mays al-Jabal, 18 in Naqurah, 5 in Alma al-Sha‘b, 31 in Yarun, 3 in Marwahin, 2 in Duhayrah, 44 in Amra, 10 in Hula and 13 in Markaba.
12 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 8 in Mays al-Jabal, 14 in Naqurah, 5 in Alma al-Sha‘b, 18 in Yarun, 36 in Marwahin, 7 in Duhayrah, 17 in Hula, 2 in Markaba and 17 in Arab al-Luwayzah.
	0830	In occupied Lebanese territory, opposite the town of Udaysah at point TP36, an Israeli enemy patrol consisting of 19 personnel approached. Several of the patrol members opened the iron gate in the technical fence, crossed it and conducted a foot patrol as far as the vicinity of point TP35. They pointed their weapons towards Lebanese army personnel. Meanwhile, a Merkava tank opposite point TP36 pointed its cannon towards Lebanese territory.
	2220 2300	In the occupied Shab‘a Farms, Israeli enemy soldiers fired a flare over the enemy Radar position for unknown reasons.
13 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Mays al-Jabal, 19 in Naqurah, 23 in Yarun, 2 in Marwahin, 29 in Amra, 8 in Hula and 1 in Arab al-Luwayzah.

	1230	In occupied Palestinian territory, opposite the town of Markaba in the vicinity of point B75, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1310 hours.
	1400	At Sha‘b al-Suwayd, on the outskirts of the town of Shab‘a opposite point OP2 of the Indian contingent of the United Nations Interim Force in Lebanon (UNIFIL), while herder Husayn Zahrah was herding livestock, an Israeli enemy patrol consisting of four soldiers attempted to abduct him. He managed to flee towards the town. They led the herd into the occupied Shab‘a Farms and released it at 1630 hours.
15 May	1555	In the occupied Shab‘a Farms, at Sha‘b al-Suwayd, on the outskirts of the town of Shab‘a, while civilian Isma‘il Zahrah was herding livestock, an Israeli enemy vehicle approached. Four soldiers disembarked and fired into the air over the herd to scare the herder, without injuring anyone. The herder subsequently returned with his herd to the town. The enemy vehicle left in the direction of occupied territory at 1610 hours.
	1700	In occupied Palestinian territory, opposite the town of Udaysah near point TP37, two Israeli enemy Humvee vehicles approached. Eight personnel in military uniform disembarked, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1730 hours.
16 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 15 in Naqurah and 3 in Alma al-Sha‘b.
	2330	Several explosions of unknown origin were heard from inside the occupied Shab‘a Farms.
17 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 1 in Hula, 1 in Markaba and 4 in Arab al-Luwayzah.
	0715	In occupied territory, opposite the town of Wazzani near pillar 40, an Israeli enemy patrol consisting of 25 personnel in military uniform approached. They opened the iron gate in the technical fence, crossed it, and carried out a foot patrol along the Wazzani River from the vicinity of pillar 40, past the vicinity of point OP8, and as far as the vicinity of the Maysat point. The patrol members planted a metal stake with a suspicious object of unknown nature on it the river bank opposite point OP8 in occupied Syrian territory. Meanwhile, a tank pointed its cannon towards occupied Lebanese territory.
	1230	The sound of military weapons fire was heard from inside the occupied Shab‘a Farms at the Summaqah and Ruwaysat al-Alam positions.
	1500	On the outskirts of the town of Kafr Shuba at Bastara, an Israeli enemy patrol consisting of two Defender vehicles and five personnel in military uniform approached. They pointed their weapons towards a Lebanese Army patrol until 1520 hours.
	2145 2215	In the occupied town of Ghajar opposite the town of Wazzani, Israeli enemy soldiers fired five flares that landed in Lebanese territory.
18 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 4 in Mays al-Jabal, 15 in Naqurah, 29 in Yarun, 5 in Marwahin, 29 in Amra, 18 in Markaba and 12 in Duhayrah.

	1000	In occupied territory opposite the town of Markaba, an Israeli enemy group consisting of eight personnel in military uniform approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1050 hours.
19 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 25 in Yarun, 6 in Duhayrah, 44 in Amra, 5 in Markaba and 10 in Arab al-Luwayzah.
	0730	In occupied Palestinian territory, opposite the town of Ramiya at points BP9 and BP10, while the Israeli enemy was carrying out excavation work to install T-wall panels, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory several times throughout the course of the work.
20 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 3 in Mays al-Jabal, 25 in Naqurah, 37 in Yarun, 12 in Duhayrah, 5 in Marwahin, 15 in Amra, 42 in Markaba and 35 in Arab al-Luwayzah.
	0215	Inside the Israeli enemy position opposite the town of Mays al-Jabal at points B71 and B71(1), enemy personnel fired seven flares, of which five landed in Lebanese territory.
	1130	In occupied Palestinian territory, opposite the town of Ramiya, an Israeli enemy patrol approached. Its members conducted surveillance in the direction of Lebanese territory using binoculars. They then pointed their weapons at members of a Lebanese army patrol. Meanwhile, an Israeli enemy Merkava tank pointed its cannon at Lebanese territory.
	2200	In the occupied Shab'a Farms, Israeli enemy soldiers fired two flares.
21 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Marwahin and 7 in Duhayrah.
	0930	In occupied Palestinian territory opposite the town of Kafr Kila in the vicinity of point B82, an Israeli enemy group consisting of 30 individuals in military uniform and civilian dress approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1000 hours.
22 May	0750	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 personnel in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point as far as point TP37. Then several of the patrol members opened the iron gate in the technical fence. Five of them took up positions inside the emplacement located at the spot while the eight others took up positions on the dirt road and pointed their weapons towards Lebanese territory.
		In occupied territory, at 0830 hours, a civilian car, a bulldozer and four workers in civilian clothing approached the dirt road. They laid electrical wires inside previously installed manholes. Meanwhile, a Merkava tank pointed its cannon towards Lebanese territory until 1700 hours.
	0800	In occupied Palestinian territory, at the north-west Abu Dajaj position, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1600 hours.

	1450	At Birkat al-Naqqar on the outskirts of the town of Shab‘a, while herder Rajih Hamdan was herding livestock, members of an Israeli enemy patrol consisting of nine soldiers fired some 15 shots from Tallat al-Saddanah into the air above the herd to scare the herder, without injuring him.
23 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 9 in Yarun, 3 in Marwahin, 1 in Duhayrah and 48 in Arab al-Luwayzah.
	0120 0133	Opposite the town of Abbasiya – Hasbaya, Israeli enemy soldiers fired four flares over the town that landed inside Lebanese territory at the Majidiyah junction.
	0800	In occupied Palestinian territory, at the north-west Abu Dajaj position, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1600 hours.
	1220	In occupied Palestinian territory, in the vicinity of point B75, an Israeli enemy Humvee vehicle approached. It positioned itself behind the earthen berm while soldiers pointed the machine gun mounted on it towards Lebanese territory until 1340 hours.
	2145	In the occupied Shab‘a Farms, Israeli enemy soldiers fired three flares.
24 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 2 in Mays al-Jabal, 13 in Naqurah, 2 in Alma al-Sha‘b, 2 in Marwahin, 1 in Duhayrah, 29 in Amra, 18 in Markaba and 49 in Arab al-Luwayzah.
	0830	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 personnel in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point as far as point TP37. Then several of the patrol members opened the iron gate in the technical fence. Five of them took up positions inside the emplacement located at the spot while the eight others took up positions on the dirt road and pointed their weapons towards Lebanese territory.
	1600	At Bastarah on the outskirts of the town of Kafr Shuba, an enemy foot patrol consisting of six soldiers approached on the road leading to the Israeli enemy Fashkul position. They fired several bursts of gunfire towards Lebanese territory for unknown reasons, without injuring anyone. The patrol left in the direction the occupied Shab‘a Farms at 1630 hours.
25 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Mays al-Jabal, 13 in Naqurah, 8 in Alma al-Sha‘b and 5 al-Luwayzah.
	0625	In occupied territory, opposite the town of Wazzani at point OP8, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1005 hours.
	1845	In occupied Palestinian territory, opposite the town of Udaysah at the Panorama point, while about 150 people were gathered inside Lebanese territory, an Israeli enemy patrol approached from behind a concrete wall opposite the aforementioned point. Patrol members threw 13 smoke bombs and two percussion bombs towards the civilians, all of which landed inside Lebanese territory without injuring anyone.

	0815	In occupied Palestinian territory, at the north-west Abu Dajaj position, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1700 hours.
	2300	On the outskirts of the town of Shab‘a, in the vicinity of point OP1 of the
	2315	UNIFIL Indian contingent, the Israeli enemy fired two flares over the Radar position that landed inside Lebanese territory.
27 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 15 in Naqurah, 5 in Alma al-Sha‘b, 31 in Yarun, 1 in Marwahin, 1 in Duhayrah, 28 in Amra, 24 in Markaba and 48 in Arab al-Luwayzah.
	1050	In Lebanese territory, on the outskirts of the town of Kafr Shuba, between Birkat Ba‘tha’il and the Summaqah position, while herder Wisam Abdul‘al was herding livestock, he was ambushed by seven Israeli enemy soldiers who attempted to abduct him. He managed to flee towards the town of Halta, but they led the herd towards occupied territory. The Israeli enemy released the herd from the Summaqah position in the direction of Birkat Ba‘tha’il, where the herder received it in full.
	1600	In occupied Palestinian territory, opposite the town of Wazzani, in the vicinity of the Israeli enemy Humayri position, two Israeli enemy Humvee vehicles and a Defender vehicle approached. Four personnel in military uniform disembarked and fired in the air towards Lebanese territory in the direction of a herder who was herding livestock, without injuring anyone. The enemy patrol left in the direction of occupied territory at 1610 hours.
29 May	0800	In occupied Palestinian territory, at the north-west Abu Dajaj position, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1700 hours.
30 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Yarun, 19 in Amra, 2 in Mays al-Jabal and 24 in Arab al-Luwayzah.
31 May	–	Landmines left behind by the Israeli enemy were detonated as follows: 30 in Markaba, 24 in Amra, 15 in Naqurah, 3 in Alma al-Sha‘b, 2 in Mays al-Jabal and 22 in Arab al-Luwayzah.
	0715	In occupied Palestinian territory, opposite the town of Udaysah, near point
	0850	TP35, two Israeli enemy Merkava tanks approached. They crossed the technical fence through the iron gate and conducted a patrol in occupied Lebanese territory as far as point TP36. They pointed their cannons towards Lebanese territory. Then a third Merkava tank approached and pointed its cannon towards Lebanese territory.
	1335	In occupied territory opposite the town of Hula, at the Israeli enemy Shaykh Abbad position, a group consisting of seven personnel in military uniform approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1355 hours.
