Land violations committed in July 2022

Date	Time	Nature of violation
1 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 23 in Yarun, 27 in Marwahin, 18 in Duhayrah, 55 in Mays al-Jabal, 16 in Arab al-Luwayzah and 10 in Markaba.
	0755	In occupied Palestinian territory, opposite the town of Hula at the Israeli enemy Shaykh Abbad position, five Israeli enemy personnel in military uniform were observed scouting the area and photographing the Lebanese side.
2 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 27 in Marwahin and 8 in Duhayrah.
	0138	Opposite the town of Shab'a, two Israeli enemy soldiers directed curses and obscene gestures towards service personnel at the United Nations Interim Force in Lebanon (UNIFIL) position.
	0700	On the outskirts of the towns of Marun al-Ra's and Aytarun in the vicinity of points B52(2) and BP23(2), a fire broke out for unknown reasons over a 10-dunum area of dry brush, resulting in the detonation of 22 landmines left behind by the Israeli enemy.
4 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 40 in Yarun, 17 in Naqurah, 9 in Markaba, 67 in Arab al-Luwayzah and 43 in Mays al-Jabal.
5 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 41 in Yarun, 47 in Marwahin, 8 in Duhayrah, 23 in Mays al-Jabal and 20 in Naqurah.
	0900	In the occupied Shab'a Farms at Birkat Ba'tha'il, nine Israeli enemy personnel in military uniform took up combat positions and pointed their weapons towards Lebanese territory.
	1510	In occupied Palestinian territory, opposite the town of Hula at the Israeli enemy Shaykh Abbad position, a group consisting of 15 personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1555 hours.
6 July	-	Landmines left behind by the Israeli enemy were detonated as follows: 48 in Yarun, 10 in Marwahin, 11 in Duhayrah, 41 in Mays al-Jabal, 14 in Naqurah, 9 in Markaba, 108 in Arab al-Luwayzah, 7 in Hula and 2 in Amra.
	0850	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 0900 hours.
	0900	In the occupied Shab'a Farms at Birkat Ba'tha'il, Israeli enemy personnel took up combat positions and pointed their weapons towards Lebanese territory.

Date	Time	Nature of violation
	1130	In occupied Palestinian territory, opposite the town of Kafr Kila in the vicinity of point B82, a group consisting of 20 Israeli enemy individuals in civilian dress approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1205 hours.
	1909	In occupied Palestinian territory, opposite the town of Hula at the Israeli enemy Shaykh Abbad position, an Israeli enemy soldier pointed his weapon towards Lebanese territory while Lebanese civilians were present.
7 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 21 in Yarun, 30 in Marwahin, 9 in Duhayrah, 19 in Naqurah, 8 in Markaba, 59 in Arab al-Luwayzah, 47 in Mays al-Jabal and 5 in Hula.
	1200	In occupied Palestinian territory opposite Sahl al-Khiyam near point B90, an Israeli enemy group consisting of 30 personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1300 hours.
	1925	From inside occupied Palestinian territory, opposite the town of Mays al-Jabal, Israeli enemy personnel took photographs and pointed their weapons towards Lebanese civilians in Lebanese territory.
8 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 49 in Yarun, 7 in Marwahin, 10 in Duhayrah, 10 in Markaba, 97 in Arab al-Luwayzah and 51 in Mays al-Jabal.
10 July	1310	In occupied Palestinian territory, opposite the town of Mays al-Jabal, an Israeli enemy soldier fired into the air towards Lebanese territory over Lebanese civilians while they were on the road along the border, without injuring anyone.
11 July	1840	On the outskirts of the town of Hula, while several civilians were on the road opposite the Israeli enemy position, an enemy soldier fired a round in the air over the civilians, without injuring anyone.
	1900 1945	Intensive medium and light machine-gun fire was heard coming from inside the occupied Shab'a Farms in the vicinity of the Ruwaysat al-Alam position.
12 July	1600	In occupied Palestinian territory, opposite the town of Hula, at the Israeli enemy Shaykh Abbad position, an enemy soldier took photographs of the Lebanese side. He left in the direction of occupied territory at 1615 hours.
13 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 17 in Mays al-Jabal, 16 in Naqurah, 26 in Arab al-Luwayzah and 4 in Markaba.
	0655	In occupied Palestinian territory, opposite Udaysah and point TP36, an Israeli enemy Merkava tank deployed and pointed its cannon towards Lebanese territory. It left in the direction of occupied territory 0710 hours.
	0750	In occupied Lebanese territory, opposite Ra's al-Naqurah east of point M1(1), four Israeli enemy workers in civilian dress workers did some welding on the iron grate in the fence. At 1120 hours, while the workers were doing the welding, a spark flew and set fire to the courtyard of the A32–1 position of the Italian UNIFIL contingent.

Date	Time	Nature of violation
	1300	In occupied Palestinian territory, opposite the town of Udaysah at point TP36, an Israeli enemy patrol consisting of five personnel in military uniform approached. They set up a green tent. At 1400 hours a Merkava tank approached from occupied territory, positioned itself behind the concrete wall and pointed its cannon at Lebanese territory. At 1420 hours, an Israeli enemy foot patrol consisting of 17 soldiers in military uniform approached. They opened the iron gate in the concrete wall, crossed through it, and conducted a patrol from the aforementioned point as far as the vicinity of point TP35 in occupied Lebanese territory. They closed the iron gate and left in the direction of occupied territory at 1455 hours.
	1317	In occupied Palestinian territory, opposite the town of Balida, an Israeli enemy tank deployed and pointed its cannon towards Lebanese territory.
	1500	In occupied Lebanese territory, opposite the town of Udaysah and point TP36 (2), an Israeli enemy patrol consisting of nine soldiers in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point as far as point TP37. Then several of the patrol members opened the iron gate in the technical fence, crossed through it by about 100 m., and pointed their weapons towards Lebanese territory.
	1700	In occupied Palestinian territory, opposite the town of Hula, at the Israeli enemy Shaykh Abbad position, a Merkava tank pointed its cannon towards Lebanese territory.
	1900	In occupied Palestinian territory, opposite the town of Yaroun in the vicinity of point B64(1), while several Lebanese civilians were in their agricultural fields, an Israeli enemy patrol approached. Its members pointed their machine guns at the Lebanese civilians in an attempt to drive them away.
14 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 12 in Naqurah, 11 in Markaba, 59 in Arab al-Luwayzah and 65 in Mays al-Jabal.
	1400	On the outskirts of the town of Shab'a at Qahwani, while citizen Yusuf Rahil was herding livestock, an Israeli enemy patrol consisting of six members tried to abduct him without success. They led the herd in the direction of the occupied Shab'a Farms. The Israeli enemy released the herd in its entirety at 1620 hours.
15 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 41 in the town of Mays al-Jabal.
	0925	In Palestinian territory, at the Israeli enemy position opposite the town of Hula, eight Israeli enemy soldiers approached. They fired three shots in the air towards Lebanese territory while some farmers were in their orchards, without injuring anyone. They left in the direction of occupied territory at 1140 hours.
	1316	In occupied Palestinian territory, opposite the town of Yarun, Israeli enemy patrol personnel took up combat positions and pointed their machine guns towards the Lebanese side while civilians were present.
17 July	1420	In occupied Palestinian territory opposite the town of Hula, at the Israeli enemy Shaykh Abbad position, a group consisting of 15 individuals in civilian dress approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1500 hours.

18 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 36 in Mays al-Jabal, 8 in Naqurah, 24 in Arab al-Luwayzah and 4 in Markaba.
	1645	On the outskirts of the town of Shab'a at Birkat al-Naqqar, while civilian Isma'il Zahrah was herding livestock, four Israeli enemy members disembarked from a vehicle and crossed through the gate 100 m. past the barbed wire fence. They attempted to abduct the herder without success. He fled with his herd in the direction of the town of Shab'a. They left in the direction of occupied the occupied Shab'a Farms at 1710 hours.
	1930	On the outskirts of the town of Majdal Silm, while the municipality was burning trash, the fire spread out of the landfill and burned an approximately 11-dunam area of dry brush, resulting in the detonation of five cluster bombs and other munitions left behind by the Israeli enemy.
19 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 47 in Yarun, 8 in Naqurah, 12 in Markaba, 36 in Arab al-Luwayzah, 63 in Mays al-Jabal and 2 in Amra.
	0915	On the outskirts of the town of Sarda, near point B93, a team from the Mines Advisory Group burned a field of dry brush, resulting in the detonation of two landmines left behind by the Israeli enemy.
	1200 1230	Bursts of medium and light weapons fire were heard from inside the occupied Shab'a Farms in the vicinity of the Ruwaysat al-Alam position.
20 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 20 in Yarun, 4 in Marwahin, 6 in Duhayrah, 15 in Naqurah, 20 in Markaba, 39 in Hula and 44 in Mays al-Jabal.
	1735	Opposite Sahl al-Khiyam in the vicinity of point B90, a civilian bus and two civilian cars approached. Some 50 personnel in military uniform disembarked. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1815 hours.
21 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 27 in Markaba, 14 in Mays al-Jabal, and 9 in Arab al-Luwayzah.
22 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 20 in Yarun, 3 in Duhayrah, 19 in Mays al-Jabal and 15 in Markaba.
	1535	On the outskirts of the town of Shab'a at Birkat al-Naqqar, while citizen As'ad Hamdan was herding livestock, he got close to the line of withdrawal and part of the herd broke away into the occupied Shab'a Farms. An Israeli enemy patrol consisting of two Defender vehicles approached. Four personnel disembarked and threw a percussion bomb near the herd. Then the patrol left in the direction of the Radar position. The herd returned to the town of Shab'a at 1635 hours.
24 July	1440	On the outskirts of the town of Shab'a at Birkat al-Naqqar, while civilian Mahir Hamdan was herding livestock, an Israeli enemy patrol consisting of a Humvee vehicle and a black four-wheel drive vehicle approached from the occupied Shab'a Farms. Three soldiers disembarked and fired into the air over the herd to scare the herder, without injuring anyone. The enemy patrol left in the direction of the occupied Shab'a Farms at 1450 hours,

25 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 27 in Yarun, 40 in Mays al-Jabal, 18 in Naqurah, 5 in Markaba and 7 in Hula.
	1300	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy group consisting of five personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1330 hours.
	1450	On the outskirts of the town of Shab'a at Birkat al-Naqqar, while civilian As'ad Hamdan was herding livestock, an Israeli enemy foot patrol consisting of four personnel approached from the occupied Shab'a Farms. They fired into the air over the herd to scare the herder, without injuring him. The enemy patrol left in the direction of the occupied Shab'a Farms at 1510 hours,
	1530	In occupied Palestinian territory, opposite the town of Hula at the Israeli enemy Shaykh Abbad position, a group consisting of three personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1600 hours.
	2200	Bursts of medium and light weapons fire were heard from inside the occupied Shab'a Farms.
26 July	_	Landmines left behind by the Israeli enemy were detonated as follows: 33 in Yarun, 21 in Marwahin, 41 in Mays al-Jabal, 15 in Arab al-Luwayzah, 7 in Markaba and 6 in Hula.
	0930	In occupied Palestinian territory, opposite the town of Kafr Kila at the Israeli enemy Jabal al-Tayyarah position, a group consisting of 25 individuals in civilian dress approached. 	0840	In occupied Lebanese territory, opposite Ra's al-Naqurah east of point M1(1), four workers in civilian dress escorted by two Israeli enemy personnel in military uniform approached. They inspected the iron separation fence. At 0930 hours, a winch with a basket approached, and the enemy started to do som welding on the iron grate in the aforementioned fence. At 1310 hours, a fire broke out from the welding. It burned dry brush in the outer courtyard position of the Italian UNIFIL contingent. An Israeli enemy fire engine put it out.
