Land violations committed in August 2022

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
1 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 29 in Mays al-Jabal, 14 in Yarun, 18 in Marwahin, 56 in Hula, 11 Amra and 35 in Arab al-Luwayzah.
	0612	In occupied Palestinian territory, opposite the town of Wazzani, at the Israeli enemy Humayri position, a Merkava tank pointed its cannon towards Lebanese territory until 0640 hours.
	1038	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1300 hours.
	1050	Inside occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 12 personnel in military uniform approached. They and opened the iron gate in the fence and crossed it by about 100 m., pointing their weapons towards Lebanese territory. They left in the direction of occupied territory at 1100 hours.
	1200	In occupied Palestinian territory, opposite the town of Wazzani, at the Israeli enemy Humayri position, a Merkava tank pointed its cannon towards Lebanese territory until 1350 hours.
2 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 18 in Mays al-Jabal, 29 in Marwahin, 4 in Markaba, 20 in Arab al-Luwayzah and 26 in Mays al-Jabal.
	1000	In occupied Lebanese territory, opposite the town of Udaysah at point TP36(2), an Israeli enemy patrol consisting of six soldiers in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then several of the patrol members opened the iron gate in the technical fence. Three of them took up positions inside the emplacement located at the spot while the three others took up positions on the dirt road and pointed their weapons at Lebanese territory.
	1015	In occupied Palestinian territory, opposite the town of Markaba near point B76, an Israeli enemy Defender vehicle approached. Three soldiers in military uniform disembarked and threw a percussion bomb in the direction of Lebanese civilians who were in their fields. It landed inside Lebanese territory without injuring anyone.
	1140	In occupied Palestinian territories, opposite the town of Markaba - Wadi Hunin near point BP34(1), while some Lebanese civilians were at the scene, an Israeli enemy Humvee vehicle approached. Several personnel disembarked and threw two percussion bombs that landed inside Lebanese territory in a minefield.

3 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 31 in Mays al-Jabal, 9 in Yarun, 17 in Marwahin, 3 in Markaba, 16 in Amra and 30 in Arab al-Luwayzah.
	0900	In occupied Lebanese territory, opposite the town of Udaysah at point TP36(2), an Israeli enemy patrol consisting of seven soldiers in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then several of the patrol members opened the iron gate in the technical fence. Three soldiers took up positions inside the emplacement located at the spot while the four others took up positions on the dirt road and pointed their weapons at Lebanese territory.
	1400	In occupied Palestinian territory, opposite the town of Udaysah near point TP36(2), an Israeli enemy group consisting of 40 personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1430 hours.
	1515	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1545 hours.
	1900	In occupied Palestinian territory, opposite Sahl al-Khiyam in the vicinity of point B90, an Israeli enemy group consisting of eight personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1950 hours.
4 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Yarun, 11 in Amra, 54 in Arab al-Luwayzah, 32 in Mays al-Jabal and 37 in Markaba.
	1110	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1220 hours.
	1200	In occupied territory, opposite the Maysat point and the town of Wazzani, an Israeli enemy patrol consisting of a Humvee vehicle approached. Three personnel in military uniform disembarked, and one of them fired five shots at the Wazzani resorts without injuring anyone. The patrol left in the direction of occupied territory at 1210 hours.
	1210	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1220 hours.
	1830	On the outskirts of the town of Hula opposite point B71(1), while one of the town's farmers was near the Blue Line, Israeli enemy soldiers fired three shots in the air towards Lebanese territory to scare him into leaving the area, without injuring anyone.
5 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 30 in Mays al-Jabal, 5 in Yarun, 47 in Marwahin, 3 in Duhayrah, 3 in Markaba, 9 in Amra and 37 in Arab al-Luwayzah.
7 August	1145	In occupied Palestinian territory, opposite the town of Yarun, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory.

8 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Mays al-Jabal, 39 in Marwahin, 6 in Markaba and 34 in Arab al-Luwayzah.
	0940	In occupied Palestinian territory, opposite the town of Hula at the Israeli enemy Shaykh Abbad position, an Israeli enemy group consisting of three personnel approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 0950 hours.
	1700	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy group consisting of three personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1730 hours.
9 August	0750	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 0800 hours.
	0800	In occupied Palestinian territory, opposite the towns of Markaba and Hula, two Israeli enemy Merkava tanks pointed their cannons towards Lebanese territory until 2000 hours.
	1200	In occupied Palestinian territory, in the vicinity of pillar 40, while several herders were present in Lebanese territory near the bank of the Wazzani River, an Israeli enemy patrol consisting of two Humvee vehicles and a Defender vehicle approached. Two personnel in military uniform disembarked and shouted curses at the herds in an attempt to drive them away. The patrol left in the direction of occupied territory at 1220 hours.
	1900	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy group consisting of four personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1730 hours.
	2130– 2200	In the occupied Shab'a Farms, the Israeli enemy fired two flares over the Radar position.
10 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 8 in Yarun, 39 in Marwahin, 4 in Markaba, 18 in Amra 11 in Mays al-Jabal and 52 in Arab al-Luwayzah.
	0850	In occupied Palestinian territory, opposite the towns of Markaba and Hula, two Israeli enemy Merkava tanks pointed their cannons towards Lebanese territory until 1430 hours.
11 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 40 in Marwahin, 3 in Duhayrah, 4 in Markaba, 13 in Amra and 51 in Arab al-Luwayzah.
	0740	In occupied Palestinian territory, opposite the town of Mays al-Jabal, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory and a Lebanese army patrol until 0915 hours.

	0940	In occupied Palestinian territory, on the outskirts of the town of Mays al-Jabal opposite point BP30, while several civilians were present in Lebanese territory, an Israeli enemy patrol approached. One of its members fired two shorts in the air towards Lebanese territory, without injuring anyone. The patrol left in the direction of occupied territory at 1100 hours.
	2120– 2200	In the occupied Shab'a Farms, the Israeli enemy fired five flares over the Radar position.
12 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 5 in Mays al-Jabal, 21 in Yarun, 56 in Marwahin, 5 in Duhayrah, 1 in Markaba, 33 in Amra, 55 in Hula and 68 in Arab al-Luwayzah.
15 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 5 in Mays al-Jabal.
	1800	In the occupied Shab'a Farms, on the outskirts of the town of Kafr Shuba at the Bastara gate, an Israeli enemy patrol consisting of a Merkava tank, a Defender vehicle and eight personnel deployed behind the blocks and took up combat positions. At 1930 hours they fired 15 shots towards Lebanese territory. The patrol left in the direction of occupied territory at 2015 hours.
16 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 4 in Mays al-Jabal and 3 in Markaba.
	1200	In occupied territory, opposite the town of Wazzani, an Israeli enemy group consisting of five individuals in civilian dress approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1300 hours.
	1200	In occupied Palestinian territory, in the vicinity of Jabal Summaqah, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1300 hours.
17 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Mays al-Jabal, 10 Markaba, 9 in Amra and 10 in Arab al-Luwayzah.
	1630	In occupied Palestinian territory, opposite the town of Hula at the Israeli enemy Shaykh Abbad position, an Israeli enemy group consisting of three personnel approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1710 hours.
	1747	In occupied Palestinian territory, opposite the town of Mays al-Jabal, an Israeli enemy soldier pointed his weapon towards a Lebanese civilian present near the Blue Line.
18 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Mays al-Jabal, 8 in Yarun, 25 in Marwahin, 3 in Duhayrah and 13 in Markaba.
	0800	In Occupied Palestinian Territory, opposite the town of Markaba near point B76, an enemy Israeli Defender vehicle approached. Two personnel in military uniform disembarked and inspected the technical fence. There were escorted by a Merkava tank with its cannon pointed towards Lebanese territory. All left in the direction of occupied territory at 0830 hours.

	1020	In occupied Palestinian territory, opposite the town of Kafr Kila at the Israeli enemy Jabal al-Tayyarah position, an Israeli enemy group consisting of 25 individuals in civilian dress approached. 	1500– 1530	Several explosions were heard from inside the occupied Shab'a Farms.
19 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 21 in Mays al-Jabal, 47 in Yarun, 48 in Marwahin, 10 in Duhayrah, 12 in Markaba, 9 in Amra and 30 in Arab al-Luwayzah.
21 August	0720	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 0740 hours.
	1450	In occupied Palestinian territory, opposite the town of Hula at the Israeli enemy Shaykh Abbad position, an Israeli enemy group consisting of three personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1510 hours.
	1550	In occupied Palestinian territory, opposite the town of Yarun, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1610 hours.
	2200	In the occupied Shab'a Farms, the Israeli enemy fired a flare that landed in Lebanese territory.
	2200– 2230	In the occupied Shab'a Farms, the Israeli enemy fired a flare over the vicinity of the Radar position.

	0800	In occupied Lebanese territory, opposite the town of Udaysah at point TP36(2), an Israeli enemy patrol consisting of eight soldiers in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then several of the patrol members opened the iron gate in the technical fence. Four soldiers took up positions inside the emplacement located at the spot while the four others took up positions on the dirt road and pointed their weapons at Lebanese territory.

Four soldiers took up positions inside the emplacement located at the spot while the four others took up positions on the dirt road and pointed their weapons at Lebanese territory.
	1035	In occupied Palestinian territory, opposite the town of Wazzani, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1120 hours.
	1300	On the outskirts of the town of Mays al-Jabal opposite point B71/1, while several farmers were in their fields along the Blue Line, an Israeli enemy patrol consisting of a Humvee vehicle approached. A soldier disembarked and tried to scare the farmer by throwing a percussion bomb, which landed inside occupied Palestinian territory.

They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then several of the patrol members opened the iron gate in the technical fence. Four soldiers took up positions inside the emplacement located at the spot while the four others took up positions on the dirt road and pointed their weapons at Lebanese territory.
	0800	On the outskirts of the town of Ramiya, in the minefield along the point BP9 road, a Lebanese army team detonated 14 anti-personnel mines left behind by the Israeli enemy.

	2130	In occupied territory opposite the town of Wazzani the Israeli enemy Humayri position, enemy soldiers fired a flare that landed in a minefield inside Lebanese territory, resulting in a fire and the detonation of seven mines left behind by the Israeli enemy.
26 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 1 in Mays al-Jabal, 59 in Yarun, 42 in Marwahin, 15 in Duhayrah, 11 in Markaba, 2 in Amra and 30 in Hula.
	1330	In occupied Palestinian territory, opposite the town of Wazzani, while civilians were present inside Lebanese territory, an Israeli enemy patrol consisting of a Humvee vehicle approached. Three personnel in military clothing disembarked and fired four shots into the air in the direction of Lebanese territory, without injuring anyone. The patrol left in the direction of occupied territory at 1335 hours.
28 August	1815	On the outskirts of the town of Hula at the Israeli enemy Shaykh Abbad position, while several civilians were present in Lebanese territory, Israeli enemy soldiers tried to scare the civilians by firing five shots and throwing a percussion bomb and four smoke bombs towards Lebanese territory, all of which landed inside Lebanese territory without injuring anyone. The civilians left the scene at 1835 hours.
29 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 3 in Marwahin and 25 in Duhayrah.
	0600	In occupied Palestinian territory, at the north-west Abu Dajaj position, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory.
	0900	In the occupied Shab‘a Farms in the vicinity of the Israeli enemy Ruwaysat al-Alam position, enemy personnel finished cutting the road to connect with the Summaqah position road inside Shab‘a Farms. It was approximately 400 m. long and 10 m. wide. They were escorted by two Merkava tanks and some 15 soldiers who deployed at the site. All left in the direction of the Ruwaysat al-Alam position at 1700 hours.
	1030	In occupied Palestinian territory, opposite the town of Udaysah near point TP37, an Israeli enemy group consisting of some 40 personnel in military uniform approached. They scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1100 hours.
	1200	In occupied Palestinian territory, opposite the town of Markaba in the vicinity of point B76, Israeli enemy personnel pointed a machine gun mounted on a Humvee vehicle towards Lebanese territory until 1310 hours.

The patrol left in the direction of occupied territory at 1650 hours.
	1815	On the outskirts of the town of Hula, opposite the Israeli enemy Shaykh Abbad position, while several civilians were present inside Lebanese territory, an Israeli enemy soldier opened fire to scare the civilians, without harming anyone.
30 August	–	Landmines left behind by the Israeli enemy were detonated as follows: 30 in Mays al-Jabal, 23 in Duhayrah, 23 in Markaba, 12 in Arab al-Luwayzah and 43 in Yarun.
	0830	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 0900 hours.
	1030	In occupied territory, opposite the town of Wazzani, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1130 hours.
