Land violations committed in September 2022

Date	Time	Nature of violation
1 September	-	Landmines left behind by the Israeli enemy were detonated as follows: 15 in Yarun, 27 in Mays al-Jabal, 6 in Naqurah, 29 in Marwahin, 6 in Duhayrah, 10 in Arab al-Luwayzah and 6 in Markaba.
2 September	_	Landmines left behind by the Israeli enemy were detonated as follows: 9 in Marwahin, 22 in Duhayrah, 38 in Yarun, 12 in Markaba, 7 in Arab al-Luwayzah, 18 in Amra and 25 in Mays al-Jabal.
3 September	-	Some 21 landmines left behind by the Israeli enemy were detonated in Duhayrah.
	1800	On the outskirts of the town of Hula, at the Israeli enemy's Shaykh Abbad position, the Israeli enemy fired two percussion shells from occupied Palestinian territory towards Lebanese territory. The shells fell in Lebanese territory without harming anyone, although several civilians were present at the time of the incident.
	2025 and 2035	In the occupied Shab'a Farms, Israeli enemy soldiers fired two flare shells over the perimeter of the Summaqah position as heavy machinery moved around in the vicinity.
4 September	0900	In the occupied Shab'a Farms, near the Israeli enemy's Ruwaysat al-Alam position, enemy personnel used a bulldozer and a Poclain vehicle to continue levelling the dirt road alongside the line of withdrawal. They were accompanied by two Merkava tanks and approximately 10 soldiers, who spread out across the area and took up combat positions. The group returned to occupied territory at 1800 hours.
5 September	_	Landmines left behind by the Israeli enemy were detonated as follows: 36 in Mays al-Jabal and 8 in Naqurah.
	0900	In the occupied Shab'a Farms, near the Israeli enemy's Ruwaysat al-Alam position, enemy personnel used a bulldozer and a Poclain vehicle to continue levelling the dirt road alongside the line of withdrawal. They were accompanied by two Merkava tanks and approximately 20 soldiers, who spread out across the area and took up combat positions. The group returned to occupied territory at 1800 hours.
6 September	_	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Duhayrah, 42 in Yarun, 33 in Mays al-Jabal, 4 in Naqurah, 6 in Arab al-Luwayzah and 3 in Hula.
	2315 and 2350	Israeli enemy soldiers fired four flare shells from occupied Palestinian territory over the occupied towns of Ghajar and Abbasiyah. The shells fell in Lebanese territory, in the vicinity of Sulayyib, and a fire broke out between the town of Ghajar and position 4–28, which is operated by the Spanish contingent of UNIFIL.

7 September	_	Landmines left behind by the Israeli enemy were detonated as follows: 9 in Marwahin, 5 in Duhayrah, 52 in Yarun, 30 in Arab al-Luwayzah, 5 in Amra, 2 in Hula and 5 in Naqurah.
	0720	In occupied Palestinian territory, opposite the town of Markaba, the cannon of an Israeli enemy Merkava tank was pointed towards Lebanese territory until 0748 hours.
	1600	In occupied Palestinian territory, opposite Sahl al-Khiyam, near point B92, an Israeli enemy group consisting of eight individuals in civilian clothing approached. They scouted the area and photographed the Lebanese side. They left at 1630 hours, heading in the direction of occupied territory.
8 September	_	Landmines left behind by the Israeli enemy were detonated as follows: 8 in Marwahin, 1 in Duhayrah, 44 in Arab al-Luwayzah, 13 in Amra, 31 in Mays al-Jabal and 8 in Naqurah.
	-	Opposite the town of Wazzani, an Israeli enemy patrol consisting of two bulldozers, one truck, two civilian vehicles and five workers in civilian clothing stopped in the northern part of the occupied town of Ghajar. The bulldozers were brought across the technical fence and used to build a road opposite the Wazzani pump, towards the SD1 road. The work ended at 1630 hours, but the vehicles were left at the location.
	1420	An Israeli enemy Humvee vehicle approached from the enemy's position opposite the town of Udaysah, in the vicinity of point TP35. The soldiers inside it pointed the machine gun mounted on the vehicle towards Lebanese territory until 1500 hours.
9 September	-	Landmines left behind by the Israeli enemy were detonated as follows: 5 in Marwahin, 19 in Duhayrah, 21 in Yarun, 37 in Arab al-Luwayzah, 10 in Amra and 4 in Hula.
	2020	In occupied Palestinian territory, Israeli enemy soldiers directed search lights from inside the tourist resort opposite Ra's Naqurah towards Lebanese territory until 2200 hours.
11 September	0730	Opposite the town of Wazzani, an Israeli enemy patrol consisting of five civilian vehicles and five workers in civilian clothing stopped in the northern part of the occupied town of Ghajar. They used an excavator that had been previously positioned at that location to build a road. The work ended at 1600 hours, and they returned to occupied territory.
	1330	An Israeli enemy Humvee vehicle approached from the enemy's position opposite the town of Markaba, in the vicinity of point B76. The soldiers inside it pointed the machine gun mounted on the vehicle towards Lebanese territory until 1400 hours.
12 September	_	Landmines left behind by the Israeli enemy were detonated as follows: 25 in Yarun, 37 in Mays al-Jabal and 7 in Naqurah.
	0730	Opposite the town of Wazzani, an Israeli enemy patrol consisting of one civilian vehicle and five workers in civilian clothing stopped in the northern part of the occupied town of Ghajar. They used an excavator that had been previously positioned at that location to continue building a road opposite the Wazzani pump, towards the SD1 road. The work ended at 1620 hours, but the vehicles were left at the location.

15 September	_	Landmines left behind by the Israeli enemy were detonated as follows: 21 in Marwahin, 11 in Duhayrah, 25 in Yarun, 20 in Mays al-Jabal, 10 in Naqurah, 14 in Amra, 7 in Markaba and 5 in Arab al-Luwayzah.
	0800	Opposite the town of Wazzani, an Israeli enemy patrol consisting of one bulldozer, one excavator and five workers in civilian clothing stopped in the northern part of the occupied town of Ghajar. The bulldozer was brought across the technical fence and used to continue building a road from the Wazzani pump towards the SD1 road. In addition, eight concrete blocks were installed at the site. During construction, they dumped rocks and dirt onto the SD1 road in Lebanese territory, blocking it completely.
	1000	In occupied territory, between the Israeli enemy's Ruwaysat al-Alam and Summaqah positions, enemy soldiers carried out manoeuvres using light and medium weapons. 	0308	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for three minutes, proceeding on its way for some 167 m. Crew members fired military weapons, directed a searchlight towards Lebanese territorial waters and sounded warning sirens. The launch then left in the direction of occupied Palestinian territorial waters.
